SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. An hourly administrator or nurse will be hired as COVID coordinator to (1) oversee & coordinate surveillance testing for COVID-19, which involves serving as the point person for Westchester DOH (WDOH) to obtain tests; working with administrators and the facilities department to oversee the testing process; providing testing results via email/call and implementing quarantine protocols for positive individuals; maintaining a log of testing and reporting to WDOH/NYS DOH; (2) coordinate contact tracing by serving as the main point of contact for all positive cases reported to the district; contacting staff/families required to quarantine and responding to questions; ensuring isolation & quarantine requirements are followed and collecting necessary documentation for return to school; supporting building administrators in identifying individuals who need to quarantine; and maintaining lists of vaccinated staff & students; and (3) assist with developing the district's COVID response by working with the district's public information officer to develop appropriate communications to district stakeholders; supporting district nursing staff to ensure consistent implementation of COVID mitigation protocols per CDC guidelines; monitoring changes in state & federal guidance to ensure compliance with the latest protocols and procedures; and collaborating with the facilities department to obtain PPE and ensure compliance with health & safety requirements in district buildings.

Through these efforts, the district anticipates improving its ability to minimize the spread of COVID among our students, staff and community. With lower spread, the district hopes for less positive cases among students and staff; thus, allowing for more in-person instruction overall. All of this work will be performed in compliance with the latest CDC guidance available.

Given the remote and hybrid environments employed in the 2020-2021 school year, we anticipate larger number softer students needing this support. Additionally, three interventionist will be hired to supplement our current AIS staff of interventionist. This will allow for addition tier 2 and 3 interventions, since, again, we anticipate more students to be behind on grade level standards due to the instruction of the prior school year. Six building subs will be hired to cover classes when teachers are quarantined so that we can have teachers continue to teach remotely to assure stability and continuity to the education program. These building subs will also be used to assist with assessments and supplementing of our intervention needs when they are not needed for covering classes.

Kindergarten and Grade 1 Math: Early Numeracy measures [AIMSweb]

Math 2-8: Computation, concepts and application [AIMSweb]

Grades 3-8 ELA & MATH NYS Assessments

Grades 9-12 NYS Regents Exams (subject specific)

5. **In the space provided below, please describe how the LEA will use the funds it reserves under section 2001(e)(1) - the required reserve of 20% of funds - to address the academic impact of lost instructional time through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year.**

The district will use funds to provide summer credit recovery for rising high school students that have not passed courses that lead to graduation. Courses will be offered in Algebra 1, Earth Science, ELA11, 10 & 9, Living Environment, Global 1 & 2, and US History in order to provide the opportunity for students who struggled in the virtual and hybrid environment to earn credits on time.

At the elementary and middle school levels, students who are not meeting standards as evidenced by local diagnostic, benchmark, and curriculum based assessments will be provided with a summer remediation program. The funding will allow the district to double the size of the program to address the needs of more students. English Language Learners (ELL) as well as students with disabilities will be included in this program based on their learning needs.

This will enable the school professionals to provide assistance and academic interventions for low-income families, students of color, English learners, children with disabilities, students experiencing homelessness, children in foster care, and migratory students. School Social Workers, Counselors, and Psychologists will be part of the building level MTSS (multi-tiered systems of support) teams reviewing the needs of children through the subgroup lens.
