UnitedHealthcare SignatureValue Harmony	Expansion into Santa Clara and Santa Cruz counties

Basic PPO Plans	Site of Care lab services incentive, waives coinsurance when members use preferred lab providers for routine lab tests Pharmacy mail-order program with opt-out option guiding members to use home delivery for non-specialty maintenance medications

Kaiser Permanente Senior Advantage Summit	Expansion into eight out-of-state regions: Colorado, Hawaii, Georgia, Northwest (Oregon, Washington), Mid-Atlantic (Virginia, Maryland, District of Columbia), and Washington
Anthem Blue Cross Medicare Preferred PPO	New supplemental benefits: Personal Emergency Response System (PERS) devices and in-home support services
UnitedHealthcare Medicare Advantage Edge	Changing from \$0 to a \$50 copay for emergency room visits
Western Health Advantage MyCare Select	Expansion into Humboldt County
