

TRANSPORTATION BEHAVIOR MATRIX

The following are suggested consequences for certain violations of conduct. This Matrix is based upon the principle that every student is expected to follow accepted rules of conduct, show respect for those around them and obey persons in authority. We emphasize that behavior that disrupts the transportation process or creates an unsafe transportation environment is unacceptable and may result in disciplinary action including but not limited to the following;
