











Gesu Students & Alumnito Stage an Original PlayCOLLABORATEin Memory of Ms. Shirley Bright.



Thanks to your support, the creative arts and cultural experiences abound at Gesu and enrich our community.

n May 22, 2015, in a gesture of unity, Gesu School students, alumni, and volunteers staged the drama, "Snake Magic" as a tribute to Ms. Shirley Bright, beloved Founder and Director of Gesu's Akybra Theater/Drama Club, Coach of the award-winning Gesu Forensics Team, and Gesu Teacher for 25 years. For five weeks, energetic high school volunteers not only finished writing Ms. Bright's original script, but also coached 16 Gesu students in grades 3, 4, and 8 through their lines and stage direction.

Dedicated Merion Mercy Academy students and Gesu alumnae, Kimberly '12 and Taylor '12, asked Gesu Principal, Sr. Ellen Convey, IHM, to complete the play and serve as co-directors, along with a friend from Merion Mercy. Alumna Lauren '12, from the Woodlynde School, took charge of props, stage crew, and costuming to help students step into character. Gesu's young actors eagerly committed to the play to honor Ms. Bright-practicing twice a week after school and diligently studying their lines at home.

The play, written in the African tradition, is narrated by the Griot, an African storyteller, who invites the audience to listen to a story about a wood cutter and his family: "Listen my children of the bright country, Africa...and I will tell you stories passed down to me by my father and his father's father before him. Stories of brave deeds of ages past. Stories filled with wonder and truth.'

The play depicts moral lessons about valuing family and the earth over material possessions.

"Snake Magic" was a moving testament to Ms. Bright's creativity and her role in sharing this important cultural tradition with Gesu students. As a Gesu alumna who is flourishing at Merion Mercy in academics and theater, Kimberly reflects on the significance of returning to mentor students and stage the play: "It makes me feel closer to Ms. Bright. It's like she's still here. I hope I can come back and do another show."

Christian, an eighth grader who performed as the Griot and participated in many plays directed by Ms. Bright, recalls her constant encouragement and celebratory spirit. He plans to continue with theater and music at SS. Neumann & Goretti Catholic High School. Like Christian, Kimberly will always remember Ms. Bright's sage advice to students before taking the stage: "Do your best, and let God do the rest." In fact, the older students passed on that wisdom to the third and fourth grade actors to inspire them before their rehearsals and performance.

The children of a wood cutter are in conflict after their father's passing. The son, Kawabana, chooses to inherit his father's possessions, while Akybra, the daughter, chooses her father's "good blessings." The play chronicles the siblings' divergent paths-Akybra's as a selfless, hardworking farmer who cares for the earth and Kawabana's as a jealous man focused on wealth. Brother and sister later reconcile through acts of compassion, transforming their lives.

Thanks to these dedicated students and volunteers, and the many Gesu parents, guardians, and friends who attended the play, Ms. Bright's legacy carries on and continues to strengthen the

n just one year, the Junior Board has made an indelible impact on the Gesu community through service and philanthropy. These dedicated young professionals not only surpassed their fundraising goal, but also cemented solid relationships—from volunteering in the classroom to building corporate partnerships.

Julianne Mesaric, who established and manages the Junior Board and serves as Director of the Annual Fund & Special Events, applauds the group's ability to "transform their ideas from their first meeting into tangible accomplishments." She observes, "What could have taken years, happened in months because the group recognizes the power of innovation, compassion, and commitment."

The Junior Board's monthly giving program garnered nearly 100 percent participation from members. For the cost of a cup of coffee, a cocktail, or one dinner out, donors help to offset the cost of a child's education through Gesu's Sponsor a Child program.

Single-handedly, the Event Committee executed Gesu's first-ever Gala After Hours Soiree, raising over \$5,000. The event drew eight corporate sponsors and close to 100 guests. Reflects Co-President, Brianna Taylor, "The group has also expanded Gesu's network and begun to develop a pipeline of young professionals who are dedicated to the success of the school."

In 2014-2015, the Junior Board raised \$8,000, with \$7,000 allocated to the Sponsor a Child program. To continue capitalizing on this success, a new finance committee is in development.

To build community, the Volunteer Committee plans service activities that target Gesu's neighborhood and connect Gesu families, staff,

and volunteers. They partnered with Smith Memorial Playground & Playhouse in Fairmount Park for two clean-up days and will continue service projects in 2015-2016.

The Volunteer Committee will soon launch the Gesu Transitions Mentoring Program to help seventh graders navigate academic and social challenges and explore careers. Its vision is well founded, harnessing the expertise of Co-Chairs Rachel Krol, Founder and Principal of Connect More, which creates negotiation workshops, and Elle Carolan, former Director of the Mentoring Program at Philadelphia City Rowing. Mentors will meet monthly with student groups and attend events, such as graduation. "We hope this will be the start of a sustainable program that will help support students as they transition from Gesu to high school, to college, and beyond," state Krol and Carolan, who aim to expand the program to grades 5-8.

To sharpen the Junior Board's leadership skills, Gesu's experienced Board of Trustees provides trainings and mentors the Executive Junior Board. In 2014, Gesu Board Chairman, J. Gordon Cooney, Jr., presented on nonprofit board governance. This year, trainings will include innovation leadership and conflict resolution and negotiation.

"Young professionals are a unique group," explains Megha Kulshreshtha, Co-President. "They can relate to a student's experience, while also bringing their own professional experience. The Gesu Junior Board hopes to be an idea hub, make an impact for Gesu School, and thrive in a supportive community with fellow young professionals."

They already have.

The Gesu Junior Board exceeds expectations in its inaugural year!

Grade 1 TEACHER

Your generosity ensures teachers have the resources to educate lifelong learners and global citizens.

Fin Williamson's first grade classroom fuels active learning. Students participate in math relay races, care for the class turtle, and act out literary classics, such as "Frog and Toad."

"My students learn best through getting up and moving," Ms. Williamson explains. "Our students at Gesu do not spend a lot of time outside and do not get a lot of opportunities to release some of the energy they have."

Ms. Williamson's student-centered teaching philosophy also has a long-term purpose. "I want my students to leave my classroom really loving the learning process, so they continue to seek out knowledge well after they are out of school," she affirms.

Ms. Williamson's creative teaching methods span every subject. An avid traveler, she collects artifacts from abroad to inspire students to explore beyond Philadelphia. She explains, "I try my best to make my students citizens of the world and incorporate cultures that they have not been exposed to into our daily classroom culture."

After visiting Hawaii, Ms. Williamson carried back lava rocks for each student and incorporated them in interdisciplinary lessons—a volcanic eruption experiment, painting, and informative writing. The class pen pal, whom Ms. Williamson befriended in China, even visited to share customs and teach Mandarin. This year, she will teach about Australia, focusing not only on geography and animals, but also the Aboriginal people, using an authentic art project to explore their struggle for equality.

While Ms. Williamson stretches students' global awareness, she also forges a tightknit classroom. She ensures that students enjoy simple childhood moments, like tasting a root beer float, and celebrate such milestones as the 100th day of school.

Observes grade partner, Kirsten Echelmeier Sams, "Erin knows each child and truly, in line with the Gesu mission and Jesuit and



IHM identities, strives to educate the whole person. This dedication does not just run September to June for the 25 students in her class, but is a cumulative and ongoing relationship well into students' years at Gesu and beyond." She recalls a poignant story of Ms. Williamson's "sensitive and generous approach" to teaching a first grader hygiene and self-care, even providing a toothbrush.

With her commitment to collaboration and innovation, it's easy to understand why her colleagues nominated Ms. Williamson for the 2015 Knetzger Outstanding Teacher Award. Says Ms. Echelmeier Sams, "Erin has found the perfect balance between challenging her students academically, socially, and emotionally while also recognizing and meeting their individual needs."

What does she find most enriching about first grade? For Ms. Williamson, teaching students to "become readers is most rewarding." In fact, she supports students after they advance to second and third grade. For five years, she has worked with the Youth Education for Tomorrow (YET) program, providing individualized instruction four days a week after school to

build literacy skills.

Ms. Williamson's dedication to Gesu extends beyond the classroom. She stages the Christmas play, organizes an Easter egg hunt with Rosemont College, and serves as a Catholic Schools Week coordinator. She is invested in building "camaraderie" among faculty and staff, regularly volunteering to plan social events.

Ms. Williamson began her Gesu career in 2008, teaching Pre-K for one year and remaining in first grade since. She holds a B.A. in Sociology from the University of Tampa and is pursuing an M.A. in Elementary Education at Saint Joseph's University. We know that her ingenuity and compassion will continue to strengthen our community and prepare her students to flourish.



VENERABLE PIERRE TOUSSAINT 1766-1853

Gesu School recognizes our leadership-level donors who have made gifts of \$50,000 and above with membership in the Pierre Toussaint Society. Venerable Pierre Toussaint, the society's namesake, is a hero from our Catholic heritage. Born into slavery in Haiti in the early 19th century, Pierre Toussaint was brought to New York City, where he became a successful hairdresser. He used his earnings to free many slaves and finally himself. Once a free man, he performed many acts of charity, including the establishment of an orphanage and a school for black children. When most fled the city during a yellow fever epidemic, he stayed to nurse the sick. His dedication to the well-being and education of the poor makes Pierre Toussaint a fitting patron for Gesu and our donors.



OSTC/EITC Companies
