POSITION SUMMARY: Under direct supervision, prepares and serves food and cleans kitchen equipment.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

- 1. Participates in preparing a variety of foods, such as soups, salads, meats, vegetables, breads, and desserts.
- 2. Makes sandwich fillings and prepares sandwiches.
- 3. Sets up foods prepared for serving on counters and steam tables.
- 4. Serves food at mealtime and performs cashier duties as assigned.
- 5. Accurately accounts for food prepared and sold.
- 6. Operates various kitchen equipment.
- 7. Cleans kitchen equipment and area, floors, scrubs counters, and cleans tables.
- 8. Stores and takes care of supplies.
- 9. Counts inventory when assigned.
- 10. Conforms to safety standards as prescribed.
- 11. Performs and participates in other related duties as assigned by the Food Service Supervisor or designee.

Mobility to work in a typical kitchen setting and use standard kitchen equipment, stamina to remain standing and to maintain concentration for an extended period of time. Vision: Frequent near acuity, occasional far acuity. Vision to read printed materials, a VDT screen, or other monitoring devices.

Environmental Conditions: Climate-controlled kitchen setting with temperatures ranging from mild to moderate cold/heat. Exposure to noise levels ranging from moderate noise to loud for occasional to frequent time periods.

Hazards: Ovens, kitchen equipment, communicable diseases, chemicals and fumes (as related to specific assignment), and power/hand-operated equipment and machinery (as related to specific assignment).
