### **It's Graduation Time!**

On June 2nd, 2023, the class of 2023 graduation ceremony will be held in the football stadium. All are welcome to attend and tickets are not needed. In case of bad weather, the ceremony will take place on June 5th. Decisions on when the ceremony will take place are made on the day of graduation around 3:00pm. Family and friends may sit on either side of the stadium.

Since the graduation ceremony takes place in June, there is a possibility of hot weather. For this reason, the graduation will be broadcasted live in the high school auditorium. The auditorium is air conditioned and can seat up to 700 people. Tickets to sit in the auditorium are not required.

On the day of graduation, the stadium gates will open at 5:30pm for visitors to get seated, while graduates take their class picture in front of the high school. Graduates will then report to the gym at 6:00pm and visitors are to be seated in the stadium by 6:30pm.

To prepare for this important event, there is a rehearsal. Graduation rehearsal will take place on June 1st. Graduates are to report to the auditorium at 10:00am in neat, informal attire. Graduation practice is mandatory unless excused by a principal. Work is not an accepted excuse. Students unexcused absent from rehearsal will not be permitted to walk at graduation. Caps and gowns will be distributed after the rehearsal in the cafeteria. Yearbook signing party will immediately follow the rehearsal.

### Israel Strikes Syria Once Again

In response to recently being attacked by rockets, Israeli officials made the decision to strike Syrian military and artillery posts on April 9th. According to the Israel Defense Forces (IDF), "...[we] launched drone and artillery strikes in retaliation, and [we] held the Syrian government responsible for everything that occurred on [our] territory." As of currently, no direct casualties have been reported in Israel and Syria.

Prior to Israel's attack on Syria, Syria had sent a total of six rockets toward Golan Heights in Israel. As revealed by Al-Mayadeen TV, "Only three of the rockets crossed into Israeli-controlled territory, with two falling on open ground and a third intercepted by the air defense system." Following such attacks, an independent Syrian organization claimed responsibility for the launching of the rockets.

With such attacks on Israel, the nation had made the decision to retaliate and strike Syria in an attempt at self-defense. The Israeli military force had fired artillery and sent aircrafts toward Damascus striking a Syrian radar station and an army artillery battery. According to the Israeli military force, "...[we] see the State of Syria responsible for all activities occurring within [their] territory and will not allow any attempts to violate Israeli sovereignty."

As of currently, no further information has been provided regarding the attacks between the two countries. With such attacks continuing to unfold and escalate, the Syrian government had claimed that Israel "...pushes the region towards a comprehensive escalation and a new phase of instability."



### The Mass Detention of Uyghur Muslims in China

In the Northwestern region of Xinjiang, China, millions of Turkic-speaking Uyghur Muslims are being detained. In 2017, an abundant number of Uyghurs were set into camps by the Chinese government. An estimated three million minorities are being held captive in these camps– a vast majority of the victims were subjected to forced labor, sterilization, and the inability to practice their religion, Islam.

When confronted initially with these threatening allegations, Chinese officials attested that these camps did not exist. However, hundreds of previous detainees had already spoken out against their past imprisonments–faulting the official's statement. Their cries spoke volumes as they reminisced the starvation, as well as the psychological and physical abuse imposed on them. The Chinese government further explained that the camps were "vocational education and training centers." The camps were intricately designed to teach Mandarin, instill "non-terrorist" citizenship, and imprint communist ideals.

According to "*II. The Origin of Terrorism and Extremism in Xinjiang,*" the use of internment camps has solely been implemented "to deal with illegal religious activities, illegal religious publicity materials, and illegal spread of religions through the internet, which has effectively curbed the breeding and spread of religious extremism." Palpably, Chinese representatives believe that these camps have proven to falter the occurrence of terrorist-linked attacks.

In retaliation to the international brutality against Uyghur Muslims, the United States has released new sanctions on multiple Chinese companies. The sanctions resulted in stopping purchases and exchanges amongst particular companies between the two countries. The undeniable evidence of these acts against human rights deters the blacklisting of many companies and many more to come.



### Swiss Woman Files Lawsuit Claiming Weak Climate Action

A group of women from Switzerland filed a lawsuit against the country stating their quality of life is affected by the lack of measures taken against climate change. This group calls themselves the Club of Climate Seniors because they are all over the age 65, one of them being a former French mayor. These women believe that these changes in temperatures are affecting their family life and if they were improved, they would have a longer life with their children and grandchildren.

This case is the first time the European Court of Human Rights has had a case dealing with climate change. These women state the heat waves are becoming harsher and harsher making them suffer more in their older ages. Due to these heat waves, a study has shown that heat mortality has increased by 30% in the last 20 years, further proving their point. Another worry of these citizens are the floods involving their homes and the way it puts their life at risk. This case is being seen as the most pivotal case involving climate change to this date.

Due to this case, Switzerland aims to reduce the domestic gas emissions 35% by 2030 and the greenhouse gasses by 50% around the same time. Because of this, eight other countries have joined this goal, including Romania, Latvia, Austria, Slovakia, Norway, Italy, Portugal, and Ireland.



### **Oil Tanker Crew Held Hostage by Pirates**

On March 31, 2023, pirates boarded a West African oil ship on the Gulf of Guinea. Out of the sixteen crew members, six were held hostage. This ship is known as the Monjasa Reformer, and the ship is owned by a Danish shipper. It is believed that on March 25th the pirates boarded the ship just southwest of Port Pointe-Noire in Congo.

Five days after the hijacking, the French navy found the ship on the island of Sao Tomé and Principe. The ship had been abandoned at this location. At the time of this discovery, no details were released on how the crew members were taken and no one knew how many crew members were abducted.

The crew had decided to seek refuge in a safe area of the ship after the pirates boarded the tanker. Unfortunately, the six discovered were taken as hostages. The crew that remained on the ship managed to message the French Navy of the untimely kidnapping of their crew members. Those who were not held hostage were said to be in good health and reports stated that no damage was done to the ship or any of its cargo.

It still remains unclear if the members that were taken hostage have been released. The identities of those involved in this situation have not been revealed. This ship has since been returned to Togo's capital. The Gulf of Guinea is known for its high level of pirate attacks. Many ships that pass through the Gulf have been robbed or have had crew taken hostage. The United Nations Security Council has made countless efforts to lower the rates of piracy.



### **Donald Trump's Indictment**

On Tuesday, April 4, former U.S. president Donald Trump was brought before a grand jury in Manhattan for an indictment. He is facing more than 30 counts of business fraud, which makes this the first time in U.S. history that a former or current president has faced criminal charges.

The case has to do with reimbursements to Trump's former attorney, Michael Cohen. Cohen was tasked with giving hush money payments to Stormy Daniels, a woman who Trump had a controversial relationship with. In an effort to pay for the reimbursement, Trump fraudulently recorded \$130,000 in expenses for Cohen's legal services.

The crime of falsifying business records can be classified as either a misdemeanor or a felony. It becomes a felony if the falsification is used to commit a different, underlying crime. Prosecutors did not specify which other concealed crime Trump attempted to commit, so it still can be either a misdemeanor or felony. This is said to be done intentionally as the prosecution keeps it open to interpretation, the jury doesn't have to find that Trump committed a specific crime, just that he attempted to commit one.

Normally, if you are found guilty of a felony count of falsifying business records, the maximum sentence is four years in state prison. Regardless, the former president's case may be different, however, if he is found guilty. His lack of a criminal history and age means that it is very unlikely that he will receive a jail sentence of any length.

John Fetterman wasn't always sad and depressed. During his campaign, when things started to look like he was going to win, he always had the biggest smile. Fetterman took a two week vacation off. His vacation isn't what you're thinking, though; he spent the two weeks in Pennsylvania with his family and constituents. John was excited most to be home so he could actually be the husband and father he wanted to be.

Many people are wondering what changed him to the point where he had to be in the hospital? Many people said the job was too difficult and stressful for Mr. Fetterman. In all reality he was depressed because he was so tied up in being the best senator he could be. He had little to no time to spend with his wife and kids.

### **Tennessee School Shooting**

Six tragic deaths in a Tennessee school have shaken many towns around the state. A 28 year old had taken the life of three children and three adults. The shooter was identified as Audrey Hale. She had once attended the Christian school where the shooting had occurred.

The former head of the school said he remembered Audrey from when she was in first grade. He has stated that he remembers her as a former student, and she had been just a typical, normal student.

Audrey had fired hundreds of shots. One hundred twenty-six were shot by 5.56 rifle rounds and 26 were 9mm rounds. It has been said that Audrey was carrying three firearms. She had entered the building by shooting through the locked glass door.

Within minutes of the 911 call, the Nashville police had shown up. Audrey had shot out of the windows at the police cars that were arriving. At 10:27 a.m. the police had killed the shooter after 14 minutes of being in the building.

Evelyn Dleckhaus, William Kinney, and Hallle Scruggs were the nine year old victims of the school shooting. Adult victims included custodian Mike Hill, substitute Cynthia Peak, and Katherine Koonce who was the head of the school.

There is still an investigation going on to hopefully find a motive for these murders. During the investigation it has been said that Audrey had left behind writings that are now being carefully studied. The investigation is still ongoing.



### **Teacher Sues School for \$40 Million**

Back on January 6th at Richneck Elementary School, a teacher, Abigail Zwener, was shot by a six year old student in her class. Zwener has now filed a lawsuit against the school administrators and the school board because she claims the school was aware of the boy's acts of violence and was also warned he may have had a firearm. The lawsuit seeks \$40 million in damages due to the school not taking any action on the day of the shooting.

Ebony Parker, assistant principal, was said to have ignored at least three warning signs from staff that he had the possession of a firearm. First it was said the students had seen him remove the firearm from his bag and put it in his pocket, but Parker insisted the hoodie pocket was too small to hold it. The administrators would not allow the teachers to search the six year old's bag because they said his parents were picking him up soon. Then, within an hour of forbidding the search, that is when Zwener was shot, leaving her hospitalized as the bullet went through her hand and into her chest.

It is said that during the first half of the year the student was required to have a parent accompany him, but on this particular day the school allowed him to be by himself. The parents have said they regret their absence that day and are praying for the teacher's full recovery. The school has not commented on the lawsuit but stated they support Zwener and her recovery. After the shooting, Parker resigned two weeks later, and the principal was reassigned to a different school and the superintendent was voted out by the school board.



### **Army Helicopter Training Crash in Kentucky**

. Nine soldiers were killed when two Army Black Hawk helicopters crashed in a training exercise in Trigg County, Kentucky. All nine of these soldiers were based at Fort Campbell in the 101st Airborne Division. Brig. General, John Lubas said one helicopter was holding five members and the other was holding four, which was typical.

The soldiers were flying the planes using night vision goggles as part of their training. There were Kentucky State Police and military investigators at the scene at the time of the crash. The helicopters have something similar to the black boxes on passenger airplanes, which records the performance of the flight and can help investigators analyze the crash. Parameters were put up around the crash scene until further investigations are made.

The names of the soldiers are not yet released due to the privacy of the families. However, a pastor in North Carolina named Tim Gore identified one of the soldiers as his son. He said his son was a real life Captain America who loved serving his country in the army. He was soon to become a registered nurse to continue his career. His wife is also pregnant with his baby that is due in six months.

This is truly a tragic loss to all of the families involved in this accident. "We're going to do what we always do. We're going to wrap our arms around these families, and we're going to be there with them, not just for the days, but the weeks and the months and the years to come," Beshear said. Many condolences and prayers are going out to all involved.



### Arkansas Man Rides Out Tornado in His Van

A tornado struck Little Rock, Arkansas on March 31st, 2023. Aid was dispatched April 1st to recover the injured and deceased. Now, new footage of a man named Cody Coombes riding through the circle of this tornado has surfaced. Coombes was inside his pest control van when the winds began to pick up. Once he had successfully survived, Coombes recalled the moment as one of the "scariest" moments of his life.

On his dash cam and mobile device, Coombes was able to capture the storm passing right over his van and leaving the debris behind. Trees had fallen, and houses were severely damaged. Coombes claimed he was sure he was going to die. "Yeah, 100% I did think I was going to die. Once I saw the winds pick up the way they did, the first thing that made me bring out my phone was the clouds in front of me were actually picking up some debris. So I saw a little chunk of wood roofing being flung around in front of me. So, I knew at that point, it had to be nearby," Coombes said in the video.

Fortunately, the tornado was directed at the back of the van, which was enclosed and secured with metal cabinets. The weight of the equipment had even prevented the van from flying with the rest of the debris. "But if I had been facing the other way it would have gone right through the windshield," said Coombes.

### **Major Storms in the Midwest**

Recently, there have been really substantial tornadoes in the Midwest. The destruction of these tornadoes started on March 31, 2023, taking at least 32 people's lives. These major storms occurred in a number of states including Arkansas, Indiana, Illinois, and Tennessee.

Most of the deaths were located in Tennessee. There were 13 people who died and many more injured. Nine of the people died in collapsed buildings. There were two children and one adult found dead from a tree falling on their house. In addition, there is damage done to the entire wooded areas and city areas. Not only are people dealing with damages, but the animals and environment are as well.

People are seeking shelter in bigger buildings after their homes have been destroyed. On Friday night in Illinois, a 50 year old woman was killed and 40 more people were injured. There was a theater with 260 people inside seeking shelter when the roof gave out and collapsed.

President Joe Biden has been trying to help the involved states. He is helping the states with federal resources. The states that he and his administration are helping are Arkansas, Illinois, Indiana, and Delaware. Also, the governor already declared a state of emergency on Friday, triggering access to statewide assistance, including the National Guard.

People with small businesses are devastated. They are stuck without their source of income with nothing to do about it. Schools and houses are destroyed. Windows are shattered and roofs are torn off. The national guard and people in the community are gathering together to help clean and fix damages.

### **False Shooting Threats in Pittsburgh**



Panic filled schools in the Pittsburgh area after a series of false phone calls regarding an active shooter on two of their school grounds. A spokesperson for Allegheny County stated that the 911- line had received two separate calls regarding an active shooter at Central Catholic and Oakland Catholic.

Authorities believed the reports were false due to similar targeted calls in numerous countries across western Pennsylvania. The police forces would still send heavily armed SWAT officers as reinforcements to ensure both schools were clear. Pittsburgh police chief Tom Strangrecki told reporters that the police treated the threats as a real incident, and the team was prepared to protect the students in the building.

The threat also spread to schools elsewhere in Pennsylvania, with numerous high schools in Eastern Pennsylvania, along with dozens of schools in Massachusetts. Pennsylvania State Police were investigating the series of phone calls made to 911 centers about schools in the area. This involved threats of an active shooter situation or a bomb threat." Authorities said they believed Wednesday's calls were "computer-generated."

Such false reports to law enforcement are often known as "swatting" and are meant to elicit a major police response. Many believe that the reason these false shooting threats occurred was because two days before, a shooter in Nashville opened fire and killed three children and three adults.



### West Easton Fire

On April 3rd, 2022 a fire burst in West Easton at 5 a.m. The fire was so big that New Jersey residents reported seeing ash falling around. There was thick, dark smoke surrounding the whole building, and it took the three different county-responding officers until 10:30 a.m. to put the fire out. They brought tanker trucks to haul in water from the Lehigh River.

No injuries were reported during the fire. The police believe the fire started from propane cans and expanded from there. The police and firefighters first-responders assured everyone that it was safe for people to go on with their normal lives. They were keeping track of the water and the air just to make sure everything was normal around the neighborhood. It was not a hazard to the communities around it.

Because of the fire, many houses did lose power around the area. It took many power lines and electric boxes with it. It lasted a day for some people even more. The Met-Ed workers tried their best to fix it fast and get it back to normal. 3,700 customers using Met-Ed lost power after the fire — 2,100 people in Easton, 1,000 in Wilson and 300 in West Easton. A lot of people were affected by the fire, but the responding firefighters did a great job of handling the situation by making sure that nobody was injured and put out the fire as fast as possible.

### **STD Crisis in the Lehigh Valley**

The Lehigh Valley, an area in Pennsylvania, has one of the highest STD rates in the United States. The latest numbers from the U.S Centers for Disease Control and Prevention state that the combined Allentown-Bethlehem-Easton area ranks 79th in the nation. The Lehigh Valley has a history of ranking among the highest in STD rate, but Pennsylvania as a whole ranks 38th as a state in that category.

With the high rate of sexually transmitted diseases per resident puts the Lehigh Valley among the top 100 in the nation. Ranking in the top 100 is fairly high considering that Pennsylvania as a state only ranks as 38th. Though it isn't the highest ranking in the state the Lehigh Valley as a whole should look to bring that number down.

They had big cases of Chlamydia and it said that 1,619 cases, 445.8 per 100,000 residents.
