### **RATIONALE:**

The purpose of this Agreement is for Doug Mann to provide the Interim Superintendent and the Board with legal services that protect them and the District in exercising their legal rights and in meeting their legal obligations under state and federal law. It is of the utmost importance for the Board and its Interim Superintendent to have the legal expertise and dedicated support of Mann to ensure that the Board and its Interim Superintendent can continue to maintain local control of all aspects of the District in furtherance of the District's Mission Statement: "To have students who lead through literacy, are empowered through experience, and contribute to their community." As special counsel to the District, Mann will provide legal services and representation on an "as needed" basis as may be requested by the Interim Superintendent, the Board President and their authorized designees.. Mann will not be expected to, nor will he, perform general or routine legal work for the District that is normally performed by the District's General Counsel and the District's independent outside law firm.
