### **Principle Responsibilities:**

- Implement lesson plans and ensure the integrity of academic time in a manner that motivates students to learn and participate.
- Create lessons on occasion for students when lesson plans are not available.
- Maintain discipline and classroom management that fosters a safe and positive learning environment for all students and staff in accordance with school policies.
- Ensure adequate supervision to assure health, welfare and safety of all students.
- Perform any other related duties assigned by administrator(s), such as supervising children on the playground, during lunch, and during carpool.
- Report to the Main Office upon arrival to and departure from school; requesting clarification of school rules and procedure, if necessary.
- Report all student injuries, accidents, illnesses, and discipline issues that arise to the appropriate authority immediately or as soon as is reasonably possible.
- Take all necessary and reasonable precautions to protect students, equipment, materials and facilities.
- Dismiss all students from the classroom at 3:05 (2:00 on Wednesdays) before leaving the building.
- Leave documentation of the daily work and student papers for the regular classroom teacher.
- Return instructional materials, equipment, and keys to proper places.
