PRINCIPAL'S REPORT:

1. This year we will be implementing the use of a Positive Behavior Interventions and Supports (PBIS) framework consisting of well-defined expectations that help students understand what is expected of them, promoting appropriate behavior.

Principals, teachers, and staff collaborated to establish grade-appropriate behavioral expectations and corresponding rewards. These expectations will be reinforced and acknowledged in various settings, including homerooms, classrooms, and school-wide events.


Our expectations focus on important objectives of respect, inclusivity, engagement, and safety which are suitable for each age group. Our catchphrase is "Rockets RISE"

A chart of school-wide norms used to help students understand each target behavior will be posted on the school website and displayed across our building in hallways, restrooms, the cafeteria, and classrooms.

We ask that parents familiarize themselves with the school PBIS matrix and language and reinforce these positive behaviors and expectations by using the same language at home. Consistency in expectations and reinforcement across both settings (home and school) helps students develop better behavior both at school and at home.

SUPERINTENDENT'S REPORT:

1. Vision Van- Lowellville is excited to announce a new partnership with Vision To Learn and to provide vision services to all of our students. This includes a routine eye exam and, if needed, eye glasses. All of these services will be provided at NO CHARGE to our families. On **Thursday, September 7th**, all students will have the opportunity to have their vision screened by licensed professionals. **All students will have their vision screened unless parents sign the opt out form.** If a student is found to be in need of glasses, the students will then select a pair of frames and be fitted for glasses that day. All of this will be provided at no charge to the families. The students will receive their glasses in about two - three weeks. Additional information and opt out forms will be shared with families in the coming weeks.

About Vision To Learn -Vision To Learn is a non-profit organization working in communities across the U.S. offering vision services to students in support of their academic achievement, free of charge.

Student Vision Services- Vision screenings will take place at your student's school. If your child does not pass the screening, they will be referred to the Vision To Learn mobile clinic to receive a routine eye exam by a licensed independent optometrist. If needed, your child may also be prescribed glasses. The optometrist may also identify and refer students in need of follow-up vision care. Eye exams do not involve eye drops or dilation.

Student Information for Vision Services -The District will share your child's name, date of birth, gender, parent/guardian name, demographic and contact information, and vision screening results with Vision To Learn. Vision To Learn will share your child's eye exam information with the District. Vision To Learn may also share limited information required to receive programmatic funding from the state.

If additional care is recommended, you may be contacted by Sight For All United to coordinate additional vision care. VTL may share information, including your child's name, reason for follow-up care, and parent/guardian name/phone numbers with SFAU. You are not required to use the services provided by SFAU. You can choose to take your child to another doctor or hospital for care, if you would like.

Medicaid Benefit Usage -Receiving vision services provided by this program will constitute a routine eye exam and – as needed – eyeglasses and dispensing of glasses that may be billed to your child's Medicaid benefits, if applicable. Please note that a no-cost eye exam and eyeglasses will be provided even if your insurance cannot be billed. You may receive a notice called an Explanation of Benefits (EOB) from your insurance carrier with information regarding the services billed and the payments that have been approved, but you will not receive any bill for the services or eyeglasses.

Glasses

If your child receives a prescription for glasses:

- 1) they will choose a frame

- 2) Vision To Learn will order the glasses
 - 3) a trained and licensed optician will dispense glasses at the school within 2-3 weeks

The non-profit was founded in Los Angeles in 2012 to ensure that every child in America has the glasses they need to succeed in school and in life. It now operates in 124 school districts and more than 325 cities in 13 states, becoming the largest school-based program of its kind.

Our Youngstown OH branch was started in the fall of 2022.

- ➔ **Screenings**
All students in the school district are first screened using the Welch-Allyn screener, to determine if they need to be seen for a comprehensive eye exam with our licensed doctor.
- ➔ **Exams**
After screening is complete, students who failed the screening and need seen will be on board the vision van for a comprehensive eye exam free of charge to the school and family.
- ➔ **Glasses**
With help from our optician, students will chose a frame that best fits their style and personality out of our 100+ frames! They will be fitted for their new glasses with our dispensing optician 2-3 weeks later. If the glasses become lost or broken- FREE replacements are provided for the life of the eye script.
