

Retirement FAQ's

1. What retirement system am I enrolled in?

- a. Your current position with APSB will determine the retirement system you're enrolled in:
 - i. TRSL: Teachers, office personnel, school food service employees
 - ii. LSERS: Bus drivers, bus attendants, maintenance employees
 - iii. **LASERS & ORP: If you had previous service credits in either of these retirement systems, please contact the retirement department (retirement@apsb.org) for further information.**

2. Do you know how much my retirement check will be?

- a. This will be determined by the retirement system (TRSL, LSERS, etc.). This cannot be determined by APSB. This formula is determined by the retirement system. The following documents will link the TRSL and LSETS benefit estimator.

Note: We strongly advise you to contact TRSL/LSERS directly for this official information. It is recommended to make a member account at [LSERS](#), [TRSL](#), or [LASERS](#) to get member access or call to speak to a retirement analyst.

3. Do I lose my sick days?

- a. Please reference APSB policy, GBRIB "Upon the retirement of any employee, or upon the employee entering DROP, or upon the employee's death prior to retirement, the School Board shall pay the employee or his/her heirs or assigns, for any unused sick leave, not to exceed forty-five (45) days. Such pay shall be at the daily rate of pay to the employee at the time of his/her retirement or death."

4. Can you tell what date I can retire?

- a. Yes, please send an email to retirement@apsb.org and one of our HR retirement clerks will be able to calculate this approximate date for you. You can expect a response within 48 hours of sending this email, due to research that may need to be done by retirement clerks.

5. When will I receive my first check?

- a. To find out this information, it is in your best interest to contact your retirement system (TRSL, LSERS, LASERS).

6. Will my retirement check increase/decrease if I get social security? How much?

- a. If you're considering retirement, contact the Social Security office to determine this amount. Social Security Contact Phone number: 800-772-1213, [Online Estimator](#)

7. What about my insurance with APSB when I retire?

- a. This will depend on the years you have enrolled in health insurance. Please contact the insurance department for additional information (employee.insurance@apsb.org)

8. When can I enter DROP?

- a. To find out this information, it is in your best interest to contact your retirement system.
