2023-2024 Course Offerings

## **Family Consumer Science (1/2 credit each course): Family Dynamics, Resource Management, & Nutrition and Wellness**

This program exposes students to a wide variety of coursework in multiple disciplines. This includes consumer science, nutrition, food preparation, parenting, early childhood education, family economics, human development, interior design, textiles, apparel design, as well as other related subjects.

## **Business, Marketing, & Finance (2 years, 4 credits): Business, Marketing, & Finance I & Business, Marketing, and Finance II**

Finance & Accounting is designed to help students develop knowledge, skills, and behavioral characteristics required in a business office. Students receive instruction in application management, financial management, telecommunication, networking, programming, input technologies, accounting, and other related business. First year for this program is Business Fundamentals.

## **Computer Science & Engineering (1 Semester, 1 credit):**

Computer science and engineering is a project-based course designed to instruct students through activities that require modeling, physical design, and coding, leading them to discover how computing and engineering work together to solve problems. This course offers students exposure to the engineering design process which introduces them to problem solving and critical thinking as well as the basics of project management and teamwork. This knowledge will assist them in making informed and meaningful decisions about high school coursework and broaden their horizons for career opportunities.

### **Teacher Academy (2 years, 4 credits): Teacher Academy I and Teacher Academy II**

Teacher Academy I is an entry-level course. Students gain foundation competencies related to students as learners, planning and assessing teaching, teaching strategies, and communication skills. Students receive hands-on field experiences. Teacher Academy II provides students with the opportunity to gain advanced skills needed to enhance them as learners, teachers, and communicators. Students receive advanced hands-on field experience.

### **Law and Public Safety (2 years, 4 credits): Law and Public Safety I and Law and Public Safety II**

Law and Public Safety I is an entry-level course. This course introduces students to professions in law enforcement and the military. Students will learn the roles and responsibilities of police, courts, and the military. The course provides students with an overview of the history, organization, and functions of local, state, and federal law enforcement. Law and Public Safety II provides students with an overview of the skills necessary for a career in fire and emergency management services. Students will examine the roles and responsibilities of a firefighter and emergency management personnel and be introduced to firefighter safety and development, including rules and regulations, proper use of personal protective equipment, and the safety principles.

### **Cyber Foundations I & II (1 credit per course):**

Cyber Foundations offers junior high students the opportunity to receive introductory instruction in computer science skills and applications that help prepare them for STEM and Business and Technology Courses.
