# Principal's Reflections

We welcomed 500 students to a new school year filled with new adventures, new friends and some familiar routines. Students participated in Morning Meetings in their classrooms and all together in our first All School Assembly on Friday, September 1st. Ask your child(ren) about the singing and masked dancers! We then hosted our Great Cereal Box Challenge and I am proud to report that we collected just over 600 boxes of cereal to donate to A Place to Turn, our local food pantry in Natick. You can view the <u>video</u> here.

Our school motto is "Chickering is a place where students learn, laugh, grow, care and make a difference." We hope that our students gathered the importance of "making a difference." As we lead up to the final day, we recognized that as much fun as the domino rally is, it is not the only reason to do this. We are using these books in school with classes to explain food insecurity and the reason for the challenge.

In addition, Mr. Carnes and I visited every classroom to read <u>Maybe</u>, a picture book by Kobi Yamada. In this Nautilus Book Award winner, we follow a story of "endless" potential.

Our Open House is scheduled for Thursday, September 28. . 6:00-6:20 Jim and Deb host parents in cafe with school wide information

6:30-7:00 and 7:00-7:30: classroom teachers host in their classrooms.Within that 30 minutes, teachers will give a 10-15 minute presentation.6:30-7:30: Specials and Special educators will be based in the Lobby.

**Chickering Citizens** has also begun. In this grade 5 program, students may apply for a variety of roles to help the Chickering community. Roles include Kindergarten safety helper (at dismissal), Art, Library, Music and PE helpers with the Kindergarten students during grade 5 recess, Lost & Found, Office helpers and even some gardeners! You can learn more about the program through the <u>slide show</u>. Many thanks to our teacher leaders on this program: Anna Ring, Anna Sawan, Christine Uminski, Chris Fraser, Dave Gaffny, Kathy Gillis, Christine Atkinson, and Julie Law-Linck.

### **Curriculum and Learning and Professional Development**

Our beginning of the year assessments are well underway, with our first round of data meetings scheduled for the week of October 9th. Teachers, Coaches, Interventionists, Educational Assistants and administrators pour over a wide collection of data to identify students who have met or exceeded benchmarks and those who have not yet. Examples of data from grades K through 5 include, but are not limited to: DIBELs Literacy Assessments, Reading Running Records, Kathy Richardson Assessing Math Concepts, IXL Math Diagnostics, student writing samples, and preliminary MCAS scores.

Students who have not yet achieved grade-level benchmarks will be assigned to small groups during the WIN (or "What I Need") block based on their instructional needs. Each grade-level has four WIN blocks in their weekly schedule. During this time, teachers and educational assistants pull small groups for focused, research-based interventions. At the end of the approximately 8 week cycle, students are reassessed and reassigned as warranted. WIN is part of our district's Multi Tiered Systems or MTSS. MTSS is a framework for meeting the needs of all students by leveraging data-driven decision making, progress monitoring, and evidence- based supports for student growth.

Preliminary MCAS scores have been released and we are planning to use them as part of the MTSS data collection as well as a curriculum review tool to assess the effectiveness of our curriculum as measured by the DESE MCAS system. More detailed analysis will be shared at a future DSC meeting.

#### Academic Spotlight:

Each month we will spotlight a grade level to help give a glimpse into our classrooms. This month we hear from Kindergarten:

Chickering School welcomes four classrooms of new kindergarteners to our community and they have already begun sprouting new roots! These bright-eyed five and six year olds have proven themselves to be willing and open-minded by bravely participating in many first time adventures:

- independently entering their new school
- joining new learning spaces with unfamiliar teachers
- building fresh friendships
- exploring foreign structures on the playground

- practicing fresh routines
- learning procedures and expectations

Kindergarten students are displaying great success remembering new classmates' names and faces, all while navigating the various personalities, too. The number one goal at the beginning of our school year is to build a positive community, which ultimately requires time and ongoing practice to fully nurture. Parents may be noticing that their kindergarten student(s) are exhausted by day's end, but children will adjust as they grow their stamina overtime. Kindergarten is a magical place where children *learn*, *laugh*, *grow*, *care and make a difference*.

# School Advisory Council (SAC)

Our new School Advisory Council will have their first meeting next week. We welcome our new members, parents/guardians: Lisa Slotnick, Collin Knight and Melissa Carballosa, teachers: Renee Grady, Anna Ring and our returning members, Alison Parker and Bob Cocks. Thank you to Jessie Hole for returning, this time as our DSC Liaison.

And with heartfelt thanks to our retiring members, many who graciously extended their terms through the COVID crisis: Rob Andrews, Jorge Fradinho, Jessie Hole as parent representatives and teachers, Nisha Hochman and Allie Vetere.

The final School Improvement Plan (SIP) is included in the DSC report, under separate cover. We started with two very broad goals and found that we needed to break them to three goals:

- 1. Chickering will continue to refine its multi-tiered system of support (MTSS) to ensure that all students have access to differentiated instruction, targeted interventions and evidence-based resources in support of their academic, social and emotional development.
- 2. Curriculum: Maintain academic excellence and rigor while maintaining a mindset for continuous improvement, research and exploration of curriculum
- 3. Chickering will continue to foster a school community free from bias and discrimination and to ensure a sense of belonging and equitable outcome for all Dover students, through inclusive communication, culture and climate.

# Safety and Security:

All students and staff participated in our first fire drill of the school year on September 5th. We practice fire drills four times in the school year in order for all students to understand the process for quickly and quietly evacuating the building. All staff have been trained by Synergy, our safety consultants. Last May, Superintendent McCoy hosted a parent information event with Synergy, our consultants for lockdown procedures. Here is the slide presentation (<u>Synergy slides</u>) from that event.

On Friday, September 22, students participated in bus evacuation practice, exiting the bus from the rear door in the event the front door was not accessible. Dover Police were here to assist.

#### **Status of Appropriations**

#### Salaries

Salaries ended the year with a positive variance of **\$29,695** (.44%). Significant item to note was the conversion of two (2) EA positions to a SPED Educator to provide more direct instruction to students on IEPs. The corresponding savings in the EA line also represents one additional EA charged to the SPED 240 Grant. Other variances resulted from post-FY23 staffing changes, leaves and coverage for those leaves (substitutes).

#### Expenditures

Overall, in-district operating expenses were over budget by **\$76,675** (7.30%). This variance was driven by the significant variance in SPED services based on outside services required to support students on IEPs.

#### Out-of-District

OOD operating costs exceeded budget by **\$397,066** (15.80%) based on placement activity throughout the year. There was new placement activity since the June report resulting in additional tuition costs of approx. **\$87,000**. Budgeted placements for FY23 were 21. Actual placements at the end of the year were 26.

#### Summary of Results

Overall results from operations for FY23 were a negative variance of **\$444,046** (4.28%). These unbudgeted costs are offset by the Circuit Breaker reimbursement of \$1,151,763 resulting in a net turn back to the Town of Dover of \$707,717.

#### **Special Revenue/Revolving Funds**

The roll-forward for the Special Revenue and Revolving Funds is included for your review. There is no significant activity to report.

We are excited to share information regarding a proposed addition to the exterior grounds of Chickering. Over the past several years, planning discussions have taken place between School Administration, Dover Parks and Recreation and representatives from Hoops for Hyde regarding renovation of the existing basketball park (on the parking lot side of Chickering) or the idea of an adding a new regulation size basketball in the same general area. The final proposal being brought forward is a new regulation size court.

For a point of information, the School Committee oversees the school building while Parks and Recreation oversees all exterior property surrounding the school including the lower Chickering Fields. Given this, the School Committee and the Parks and Recreation Commission work collaboratively when projects such as these are proposed. The outdoor classroom was the most recent example of this type of collaboration.

The Parks and Recreation Commission met on September 14<sup>th</sup> and approved the idea of the court addition and will work with School Administration/School Committee to finalize procurement procedures, usage protocols and long-term maintenance responsibilities. We plan to attend the Parks and Recreation's committee meeting in late October to further discuss the details. More information will be shared with the Committee at a future meeting.

Attached for additional background on Hoops for Hyde and this project is a notification shared with the Hoops for Hyde community.

#### Information shared by Hoops For Hyde

#### 5) Audited FY22 Financials

The FY22 Audited Financial Statements and the Single Audit Compliance Report were reviewed by John Lafleche, Treasurer, and Robert Brown, Principal RE Brown & Company. The Region received a clean opinion with no management letter necessary. The Single Audit Report is required for organizations that expend \$750,000 or more in federal funds during any fiscal year. The Region expended \$1,052,584 in federal awards in FY22, including \$500,000 from the Department of Agriculture primarily related to the federal funded universal free lunch program. Since the universal free lunch program is now state funded the Region does not expect to exceed the \$750,000 that triggers filing of the report.

#### 6) Reports

- Superintendent Report Beth McCoy provided an update from her office including: the Educators' Contract has been approved by the union; Synergy 911 has recently been on campus to conduct training; Ann Dever-Keegan has been named as the Interim Middle School Principal; and there are two finalists for the position of HR Director.

#### 7) Financial Reports: FY23 Monthly Report as of May 31, 2023

- Revenues Chapter 71 revenues reflect a 73% reimbursement rate, the Administration anticipates a slightly higher reimbursement rate once the final payment is received but have not made any projections on the current statements.
- Salaries overall, salary expenditures are within 0.81% of budget.
- Expenditures with DSEA negotiations taking place this year, there are increased costs in legal fees which is included in the May statement.
- Pro-forma Roll-forward of E&D with the current projections and proposed uses, E&D at June 30th is \$1,129,798 or 4.04% of the FY24 operating budget.
- FY24 Capital Use of E&D and Community Education Funds the following capital projects are proposed to be funded with E&D: high school floor replacement \$120,000; Lindquist student restroom renovation \$30,000; and Bleacher/Press Box Renovation \$125,000 totaling \$275,000.

Maggie Charron made a motion to transfer \$275,000 of June 30, 2022 certified Excess & Deficiency funds to the Region's Capital fund to cover costs for approved FY24 capital projects as presented. Angie Johnson seconded. 23-12 VOTE: 6 - 0

• In addition to the above approval of E&D funds for the Bleacher/Press Box Renovation, the Administration also requested a transfer of \$100,000 from Community Education to partially fund the structure expenses.

Colleen Burt made a motion to transfer \$100,000 of funds from the Community Education Fund to the Region's Capital fund to cover costs for the Bleacher/Press Box Renovation as presented. Mark Healey seconded. 23-13 VOTE: 6 - 0
