**Overview of the Citizens' Oversight Committee**

In November 2000, the voters of the State of California authorized an amendment to the California Constitution (Proposition 39) lowering the voter approval requirement from 2/3rds to 55% for school districts that provide voters a specific list of projects, a committee of appointed citizens to oversee the expenditure of funds and an annual performance audit and financial audit of the bond funds and bond projects. Proposition 39 provides that the Citizens' Oversight Committee (COC) shall have at least seven (7) members who shall serve up to three (3) terms of two (2) years each.

In November 2020 the residents of the Cambrian School District passed Measure R under the Proposition 39 statute, and are hereby seeking applications for members willing to serve on the Measure R COC.

**Duties**

Duties of the COC will include:

- Meet at least twice per year, following Brown Act procedures.
- Monitor progress of Bond projects.
- Ensure Bond funds are spent only on projects listed in the Bond Project List and that no funds are used for prohibited expenses.
- Receive and review copies of the annual performance and financial audits of Bond projects as required by Statute.
- Provide information to the public on the progress of Bond projects and expenditures of Bond funds.
- Provide an annual report to the Governing Board.
