Notice of Public Hearing and School Budget Re-Vote
Lansingburgh Central School District at Troy
County of Rensselaer, New York

NOTICE IS HEREBY GIVEN that a public hearing of the qualified voters of the Lansingburgh Central School District, Rensselaer County, New York, will be held in the Turnpike Elementary School, located at 55 New Turnpike Road, Troy, New York, on Wednesday, June 5, 2019 at 6:30 p.m. prevailing time, for the presentation of the revised budget document. Beginning on June 4, 2019, copies of the revised budget document will be available, upon request, at the District Office located at 55 New Turnpike Road, Troy, New York, weekdays between the hours of 8:00 a.m. and 4:00 p.m.

AND FURTHER NOTICE IS HEREBY GIVEN that a special meeting and re-vote will be held on June 18, 2019 between the hours of 12:00 noon and 9:00 p.m., prevailing time, at the Speigletown Volunteer Firehouse, 146 Speigletown Road, Troy, New York (Election District No. 1) and at the Knickerbacker Ice Arena, 191 103rd Street, Troy, New York (Election District No. 2), at which time the polls will be opened to vote by voting machine upon the following items:

1. To adopt the annual budget of the School District for the fiscal year 2019-2020; and to authorize the requisite portion thereof to be raised by taxation on the taxable property of the District.

AND FURTHER NOTICE IS HEREBY GIVEN that a copy of the statement of the amount of money which will be required to fund the School District's budget for the 2019-2020 fiscal year, exclusive of public monies, may be obtained by any resident of the District during school business hours (8:00 a.m. – 4:00 p.m.) beginning June 4, 2019, except Saturday, Sunday or holidays, at the District Office, the Public Library, and at each of the following schools: Turnpike Elementary School, Rensselaer Park Elementary School, Knickerbacker Middle School and Lansingburgh High School.

AND FURTHER NOTICE IS HEREBY GIVEN that applications for absentee ballots are obtainable from the District Clerk at the District Office located at 55 New Turnpike Road, Troy, New York between the hours of 8:00 a.m. and 4:00 p.m. Completed applications must be received by the District Clerk at least seven (7) days before the election if the ballot is to be mailed to the voter, or the day before the election if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the District Clerk no later than 5:00 p.m., prevailing time, on June 18, 2019.

A list of persons to whom absentee voter ballots have been issued will be available for public inspection during regular office hours of 8:00 a.m. and 4:00 p.m. in the District Office until the day of the election. Any qualified voter may, upon examination of such list, file a written challenge of the qualifications as a voter of any person whose name appears on such list, stating the reasons for such challenge. Such written challenge will be transmitted by the District Clerk to the inspectors of election on the day of the vote.

AND FURTHER NOTICE IS HEREBY GIVEN, that personal registration of voters, pursuant to Section 2014 of the Education Law, will be held on Wednesday, June 12, 2019 between the hours of 12:00 p.m. - 6:00 p.m. and the place for said registration will be held at the District Office located at 55 New Turnpike Road, Troy, New York. At such time, the members of the Board of Registration will meet to prepare the register of the school district and during which time, any person will be entitled to have his or her name placed upon such register, provided that at such meeting of the members of the Board of Registration he or she is known or proven to the satisfaction of such Board of Registration to be then or thereafter entitled to vote at the school election for which such register is prepared. The register, prepared pursuant to Section 2014 of the Education Law, will be filed in the office of the District Clerk and such register will be open for inspection by any qualified voter of the District beginning June 13, 2019, between the hours of 8:00 a.m. - 4:00 p.m. in the office of the District Clerk.
