**SUMMARY & BACKGROUND**

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. APPLICATION PROCESS FOR LEA ALLOCATIONS OF ARP-ESSER SEA RESERVE FUNDS

The federal ARP statute requires SEAs to reserve:

- not less than 5 percent of the total amount of grant funds awarded to the State (\$449.4 million) to carry out activities to address the impact of lost instructional time by supporting the implementation of evidence-based interventions;
- not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based summer enrichment programs; and
- not less than 1 percent (\$89.9 million) to carry out the implementation of evidence-based comprehensive afterschool programs.

Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The Lansingburgh Central School District has sought the input of all stakeholders in determining it's plan for the use of the American Rescue Funds (ARP). Parents, students, staff and community members were asked to provide input into our plan prior to the initial application. The district preliminary plan was outlined on the district website as well as at the Board of Education meeting.

The District is having ongoing communication with the Board of Education at least monthly, sometimes bimonthly, on how these funds are being spent. These meetings are open to the public and community input is sought during these meetings.

Family engagement is done formally on a quarterly basis at each building level with the Parent Engagement committees.

Staff and student input is sought daily through the various offerings we have made available to both staff and students with the funds.

The district also monitors social media daily and seeks input in this medium. Surveys are also created and sent out at various times of the year to gain additional insight.

3. **In the space provided below, please describe the extent to which and how the funds will be used to implement prevention and mitigation strategies that are, to the greatest extent practicable, consistent with the most recent CDC guidance on reopening schools, in order to continuously and safely open and operate schools for in-person learning.**

**In-Person Learning**

Prioritizing in-person learning is a key point of both the CDC and AAP guidance. If guidance permits the loosening of some restrictions (ex. reducing the amount of required physical distancing between students in classrooms), Lansingburgh is planning **a 100% return to in-person learning with no option for remote learning**. The one exception is for students who are deemed medically vulnerable by a medical profession, in which case, some type of distance learning program will be assigned. Additionally, we will have plans in place to shift to full remote learning if a full or partial closure in our school buildings is needed due to COVID-related issues.

**Masks**

The CDC and AAP recommendations call for all teachers, staff, students and visitors to continue wearing masks when inside K-12 school buildings, regardless of vaccination status. We plan to follow these recommendations and expect **all Lansingburgh students and staff will be wearing appropriate face masks in school buildings for the 2021-2022 school year**. Mask breaks will be given periodically throughout the day. At this point, we have not determined if students and staff will need to wear masks when outdoors at school.

**Daily COVID Screenings/Attestations**

If allowed, Lansingburgh does not plan to have daily student COVID screening attestations. We still strongly encourage families to be very mindful of when students or someone in their household are exhibiting COVID symptoms. In either case, students should not come to school.

As an added mitigation strategy, we are currently working with the Rensselaer County Department of Health to provide screening testing that will help to identify infected people, both with or without exhibiting symptoms, who may be contagious. Parental consent to test is required, in accordance with the Family and Educational Rights and Privacy Act.

**Physical Distancing in the Classroom**

Even with our planned universal masking in place, we still expect some form of physical distancing in Lansingburgh this year. If allowed, **we plan to reduce the required amount of physical distance between students from 6 feet to 3 feet when in the classroom**. Increased spacing will likely be needed for Physical Education, Choir and Band.

**Cafeteria/Meals**

Meals will be distributed in the kitchen area and eaten in the cafeteria. Physical distancing will be maximized to the greatest extent possible in both areas. Mask removal will be limited only for the duration of eating to limit potential exposure. Tables will be cleaned between uses and hand washing/sanitizing before and after will be strongly encouraged.

**Student Transportation**

We are anticipating that school transportation follows the same safety guidelines as public mass transportation. Universal masking on school buses, eliminating the need for household seating cohorts on busses and a reduction in required physical distancing on busses, would permit Lansingburgh to transport more students in 2021-2022.

**Positive/Suspected COVID Cases in School & Contact Tracing**

We anticipate following similar protocols for this as we did in 2020-2021. When made aware of a positive COVID case in the schools, we will notify impacted Lansingburgh students and staff members ASAP about their exposure and the need to quarantine. We will inform the Rensselaer County Health Department of the case and work with them to ensure proper contact tracing is carried out in our school community.

**Learning During a Quarantine Period**

Should students need to quarantine due to possible COVID exposure, we are still required to provide some form of appropriate education while they are not physically attending school. The District is still exploring various instructional models to accommodate students' needs.

**Athletics/Extracurricular Activities**

Currently, the Capital Region Workgroup is collectively establishing guidance for athletics. This includes all levels (varsity, JV, modified) and all levels of risk (low, moderate, high).

Finally, if you plan to have your eligible student or yourself vaccinated prior to the first day of school (September 7), I encourage you to do so as soon as possible. The Rensselaer County Department of Health has set up numerous mobile vaccination clinics, making it easier than ever to get vaccinated. While not 100% effective, vaccinations are still the best layer of protection available to mitigate the harmful effects of this virus, therefore remaining our best option to minimize disruptions in our educational programs at Lansingburgh.

**4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.**

Common assessment data will be provided from Questar III based upon Critical Concepts from the New York State Learning Standards. The District uses iReady to address individual student learning deficits in both ELA and Math. The diagnostic is given three times per year and allows students to progress through skills that the diagnostic has identified as below grade level. In addition, the District will utilize Fountas and Pinnell assessments to measure reading groups, and then target small group instruction to those student needs. In primary classrooms, teachers will collect data on letter/sound identification, sight word identification, and phonological awareness, based on Wilson's Foundations program. Mid-year common assessments and midterms will be analyzed as well at the secondary level.

The district has hired four AIS Math providers and two AIS reading teachers for the elementary schools. In the middle school, three AIS math and reading teachers were hired. Those AIS providers collaborate with the classroom teachers in order to identify deficits based on data collection. The teachers pull small groups for targeted instructional of foundational skills during the ELA or Math block. Interventions are also provided during an Intervention block K-5 and during the extra period of ELA and Math Seminar in grades 6-8. Additionally, the district has added an Rtl coordinator in order to assist teachers in identifying student deficits and providing a tiered approach to closing those deficits. The Rtl coordinator creates individualized plans for students through the Instructional Support Team, using AIS providers to target students deficits. Teachers progress monitor students every six-weeks before the team reconvenes.

The district has hired four AIS Math providers and two AIS reading teachers for the elementary schools. In the middle school, three AIS math and reading teachers were hired. Those AIS providers collaborate with the classroom teachers in order to identify deficits based on data collection. The teachers pull small groups for targeted instructional of foundational skills during the ELA or Math block. Interventions are also provided during an Intervention block K-5 and during the extra period of ELA and Math Seminar in grades 6-8. Additionally, the district has added an Rtl coordinator in order to assist teachers in identifying student deficits and providing a tiered approach to closing those deficits. The district will implement a summer academy at each of its four (4) schools. The program will run four days a week for six weeks. The program will focus on preventing regression and providing extra instruction for students who lost instructional time. The district is also offering both academic, art, music and athletic after care offerings for all students in the district. Furthermore the ARP funds will be used to add AIS and reading teachers to the academic school year. These teachers will work with students throughout the school year to provide academic support.

The interventions that the District will implement, will focus on all learners, to address the academic impact of lost instructional time. In particular, students from low-income families, students of color, English Language learners, students with disabilities, students without permanent housing, will have access to enriched afterschool programming. The afterschool programming will include both academic and enrichment offerings, as well as opportunities to continue to build relationships with staff members, to address social emotional learning needs. In grades K-5, an intensive classroom will be added at each grade level with a full-time teaching assistant, to provide targeted support for students. The students targeted will have been identified through multiple measures of data and are currently undergoing the RtI process.

The district will be participating in a national learning collaborative with the National Center for Safe, Supportive Schools. This collaborative will provide free professional development and consultation to the district and its partners for the development of culturally responsive, trauma-informed, school mental health systems. The Lansingburgh Schools NCS3LC Leadership Team includes representation from:

- Lansingburgh Central Schools
- The New York State Education Dept
- NYS Office of Mental Health
- Questar III BOCES
- Rensselaer County
- The Rensselaer County Dept. of Mental Health

The district will also build further upon its work to create trauma sensitive environments in each school building through each school's Trauma Sensitive Schools Team. Students in grades PreK-10 will receive coursework in social emotional learning through Second Step curriculums and the M-POWER curriculum.
