- Security Bonds
Security bonds be set at a minimum of \$10,000 for the board treasurer and \$100,000 for employees.
- Depositories
Depositories will be the Banks of Cass County, Michigan Class, and the Michigan Liquid Asset Fund (MILAF).
- Check Signature Authorization
Superintendent, Chief Financial Officer, Accounting Supervisor, and the Board Treasurer be authorized to sign checks for Accounts Payable, Payroll, Student Activities, and Edustaff Accounts.
- Memberships
Michigan Association of School Boards and School Equity Caucus organizations.
- Retainer Contracts
Thrun Law Firm, P.C. as legal counsel for state level matters and labor negotiations and Clark Hill PLC as legal counsel for special education matters and that a retainer be paid to each firm.
- Newspapers of General Circulation
Marcellus News and Leader Publications be designated as the newspapers of general circulation for the current school year.
- Compensation for Board Members
