

# WHAT IS A COMPACT?

A compact is a written agreement, jointly developed by families, students, and school staff. It outlines how each partner (school, family, and student) will share the responsibility for improved student achievement. This partnership agreement encourages the children we share to become lifelong learners and responsible citizens.

Every Title I school must develop a home-school compact according to the Every Student Succeeds Act (Section 118d) "...Each school served under this part shall jointly develop with parents for all children served a school-parent compact that outlines how parents, entire school staff, and students will share the responsibility for improved student academic achievement and the means by which the school and parents will build and develop a partnership to help children achieve the State's highest standards."

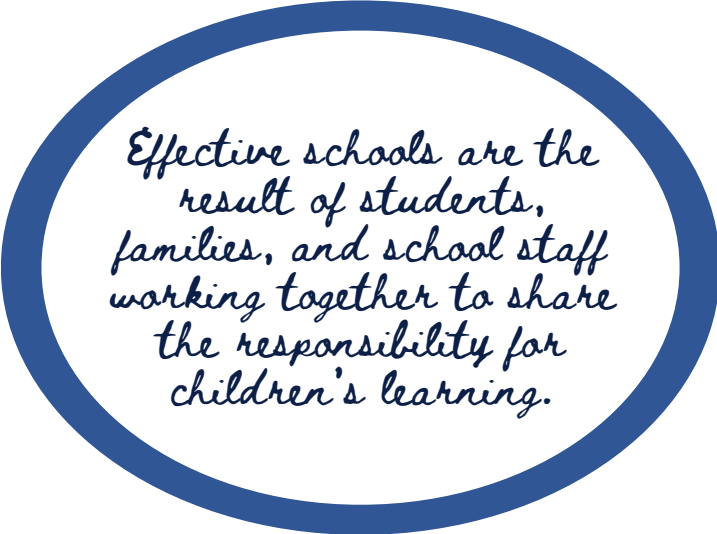

## AS A SCHOOL, WE WILL

- Provide high quality curriculum and instruction in a supportive and effective learning environment that enables students to meet the state's achievement goals.
- Respect each student
- Recognize student achievement and improvement
- Provide instruction to meet the needs of all students by collaborating and planning instructional programs for students.
- Provide information to parents and students about their student's progress and behavior
- Implement learning goals for individual students and groups of students
- Provide families with reports on their student's progress, specifically quarterly interim and progress reports, and by holding four family-teacher conferences during the school year
- Provide families with reasonable access to staff via email, phone and conferences
- Provide volunteer opportunities for families
- Provide materials and training to help families work with their students to improve academic achievement
- Ensure parent and family communication is easy to understand
- Inform families of their right to request information regarding the qualifications of their student's classroom teacher
- Involve families in the planning and design of the school's Family Engagement Plan and Home-School Learning Compact
- Hold meetings to review the Title I program and requirements
- Provide families with a description/explanation of the school's curriculum, state tests, and grade-level expectations
- Educate staff on how to work with families as equal partners
- Share the CCPS Family Engagement Policy, CCPS Title I Parent and Family Engagement Policy, CCPS Complaint Procedure, RME Home-School Learning Compact, and RME Family Engagement Plan on the RME website
- Coordinate, when appropriate, with other community agencies to support family needs



## AS FAMILIES, YOU WILL

- Support school rules
- Ensure that your student's homework is completed
- Volunteer at school when possible
- Be involved in making decisions about your student's education
- Stay informed about your student's attendance and education, and communicate with the school promptly and appropriately by reading all notices received about your child via take-home folders and email
- Attend/participate in at least one family-teacher conference per year/per student
- Attend/participate in at least one family engagement event per year
- Provide time for reading for student reading, both independently and as a family



## AS A STUDENT, YOU WILL

- Attend school daily and make an effort to pay attention, work hard and do your best in class
- Accept responsibility for your own actions
- Stay on task and follow rules
- Do your homework every day and ask for help when you need it. Read every day - at home
- Say "NO" to bullying
- Support Robert Moton's Triple "R" behaviors
- Take all information that you receive from school each day and give it to an adult at home. Bring it back on time, if needed
