THEREFORE, be it resolved s that the bid be awarded to Wallkill Group, Inc. 3505 Rt. 94, Suite 1A, Hamburg, NJ 07419 in the amount of \$2,152,000.00, inclusive of Add Alternate #1 in the amount of \$15,000, per the Project Specifications, inclusive of the bid allowance set forth in the specifications, subject to the terms and conditions of a contractual agreement pending review by Board counsel, and which the Board President is authorized to execute on behalf of the Board.
