### Threats of Violence by Students

The Board of Education finds that threats of violence are disruptive of, and incompatible with, the maintenance of an appropriate educational atmosphere in schools. Particularly in view of the many incidents of actual student violence in schools around the nation in recent years, such threats cannot be ignored as harmless talk. The Board therefore adopts this policy regarding threats of violence by students.

- 1. Threats of Violence Prohibited: Threats of violence toward other students, school staff members, or school facilities generally are prohibited and may result in suspension or expulsion, regardless of whether the student has engaged in such conduct previously.
- **2. Mandatory Reporting:** All employees and students are required to report evidence of threats of violence to their building Principal, or to the Superintendent. Such reports shall be investigated by the building Principal or his/her designee.
- **3. Documentation:** All such reports shall be documented by the Superintendent or his/her designee, and, in regard to any that are regarded as not sufficiently credible to warrant investigation, all reasons and bases for such conclusion shall be stated in the documentation.
- **4. Reports to Law Enforcement Authorities:** In cases of threats that may constitute a violation of the criminal law, the Superintendent shall notify law enforcement authorities.
- **Procedure; Sanctions:** Regular education students who are charged with violations of this policy may be placed on in-school suspension pending investigation of the charge. In the event the charge is substantiated. A student will be disciplined in accordance with Board policy.
- **6. Conditions for Return from Suspension; Documentation:** As a condition or conditions of a student's return from suspension or expulsion for a violation of this policy, the Superintendent or his/her designee shall consider, and may impose, the following, individually or in any combination, as well as other conditions deemed necessary or appropriate:
  - a. That the parent or guardian of such student shall provide a documented opinion by a licensed professional that the student does not represent a threat of harm to himself/herself or to others, and, for a period to be determined by the Superintendent or his/her designee, that the parents or guardians provide regular documented updates of such opinion.

#### **6. Conditions for Return from Suspension; Documentation** (continued)

- b. That the parent or guardian of such student agree that, for a period to be determined by the Superintendent or his/her designee, a parent shall check the student for weapons at home, and shall accompany the student to the school office upon arrival at school at the beginning of each school day, at which time the student shall be searched for weapons or other contraband by school personnel;
- c. That the parent or guardian of such student agree that, for a period to be determined by the Superintendent or his/her designee, the student shall be prohibited from leaving campus during the school day, and that during any non-class time, the student shall remain in a monitored, segregated environment;
- d. That the parent or guardian of such student agree that, for a period to be determined by the Superintendent or his/her designee, the student shall be transported home from school by the parent at the end of the school day;
- e. That the parent or guardian agree that for a period to be determined by the Superintendent or his/her designee, the student shall not be permitted to participate in any extracurricular activities, or school functions except classroom instruction during the school day; and
- f. That the parent or guardian agree that, for a period to be determined by the Superintendent or his/her designee, the student will not be permitted to enter or be present on school premises except during the regular school day, and that the parent or guardian will enforce such prohibition by appropriate means.
- g. In permitting a student to return to school from a short term or long term suspension, conditions imposed by the Superintendent or his/her designee, including those set forth in this subparagraph, may be incorporated into a written agreement to be signed by the parents or parent of the student in question.
- h. In permitting a student to return to school from a suspension or expulsion, the Superintendent or his or her designee shall document the reasons and bases for permitting such return, and such documentation shall include reasons and bases for imposing or not imposing the conditions set forth in this subparagraph.

# **Response to Death Threats/Targets lists:**

## Take all reports of threats seriously

- 1. Investigate, interview students, counselor, teacher.
- 2. Suspend for threatening behavior.
  - a. Even if a joke.
  - b. Consider mobilizing response team or suicide policy if appropriate.
- 3. Call police?
  - a. Case by case analysis investigate details, talk to other students.
  - b. If any reasonable suspicion of possible danger contact police.
- 4. Notify anyone else?
  - a. Automatic notification to threatening student's parents (suspension letter).
  - b. If any reasonable suspicion of possible danger, notify victim and victim's parents.
- 5. Consider referral to Child Study Team or Crisis Intervention Team.
