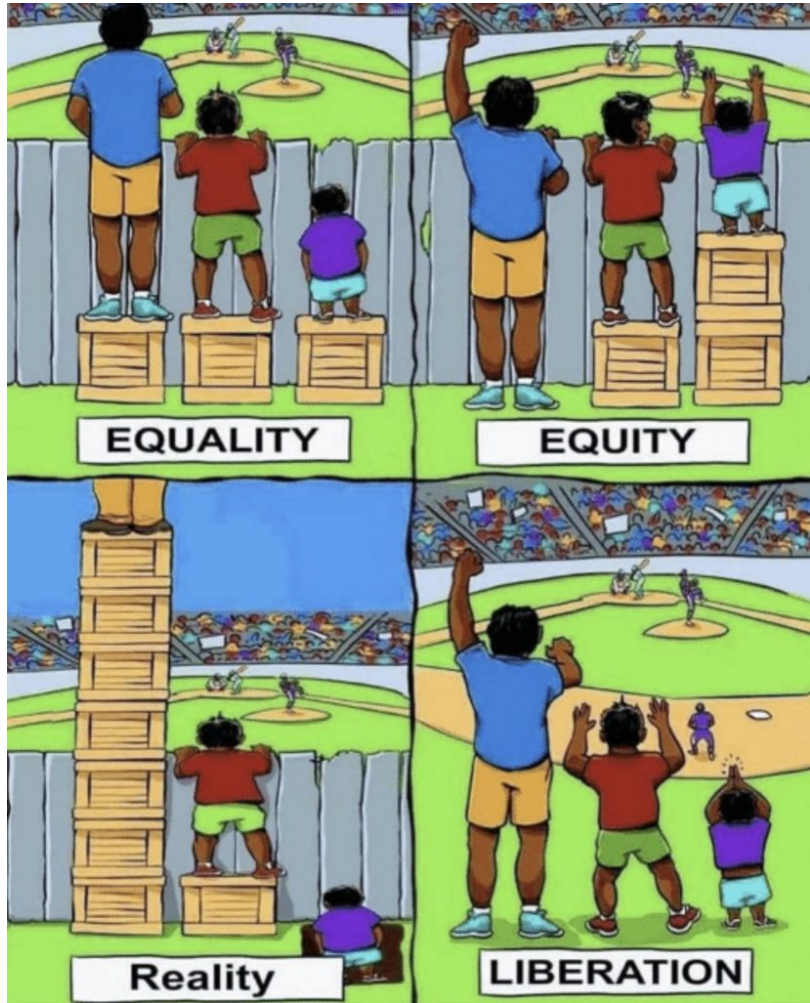

All positions are annual positions, can remain in position longer. This is year 2 for many of us in current positions.

From the bylaws:

1. Officers shall be elected by ballot annually in April at a general membership meeting. However, if there is but one nominee for any office, it shall be in order to move that the Secretary cast the elective ballot of the organization for the nominee.
2. There shall be a Nominating Committee consisting of three (3) members. The Principal shall serve as an ex-officio member.
3. Officers shall be elected by ballot annually in April at a general membership meeting. However, if there is but one nominee for any office, it shall be in order to move that the Secretary cast the elective ballot of the organization for the nominee.
4. There shall be a Nominating Committee consisting of three (3) members. The Principal shall serve as an ex-officio member.  
**2nd VP is the chair of the nominating committee.**
5. **The Nominating Committee shall make a selection of nominees for each office to be filled and report those selections at the March meeting.**
6. Solicitation for members interested in holding office shall be done at least one month prior to the presentation of nominees at the March meeting.
7. Officers, with the exception of the Treasurer, shall assume their official duties **at the close of the May meeting** and shall serve for a term of one (1) year.
8. The newly elected Treasurer shall assume official duties **at the beginning of the new fiscal year** and shall serve for a term of one (1) year.
9. No person shall serve more than two (2) consecutive terms in the same office without separate approval by the Executive Board.
