# THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRICT NUMBER ONE OF TULSA COUNTY, OKLAHOMA MINUTES OF THE REGULAR MEETING OF JUNE 20, 2023

A regular meeting of the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, was held on June 20, 2023, commencing at 6:30 p.m., in the Cheryl Selman room, ground floor, at the Charles C. Mason Education, 3027 S. New Haven Avenue, Tulsa, Oklahoma. #### **BOARD MEMBER REPORTS**

Board Member Marshall shared her opportunity to attend a conference with the Oklahoma Parent Center as well as information regarding some of the speakers.

Ms. Woolley thanked all of the teachers for their hard work in assisting students in reaching their reading proficiency goals. She noted that from Spring 2022 to Spring 2023 the number of students meeting proficiency rose by 5% equating to approximately 900 students. She also highlighted during the same time frame that there were 1,600 additional students that met their literacy growth goals, greatly enhancing those students' lives.

Ms. Woolley also shared that when she was running for re-election that it was important to her constituents that she supported students that are part of the LGBTQIA community. In honor of Pride Month Ms. Woolley wanted all staff, students, and families of Tulsa Public Schools that are included in the LGBTQIA community to know that they are seen, loved, and valued for exactly who they are.

Ms. Diamond Marshall shared that those in our community who are part of the LGBTQIAA community who are transitioning may need additional support during the power outage to secure their medicines. She encouraged those who know of supports during the outage to share that information on social media and various platforms to assist those in need.

# CITIZENS COMMENTS

### SUPERINTENDENT'S REPORTS/PRESENTATIONS

Dr. Gist announced that Will Rogers Middle and High School ad hoc committee will be gathering community input on the naming of the Will Rogers baseball field and shared that the link to submit recommendations would be posted on tulsaschools.org from June 21 through July 5, 2023.

Additionally, Dr. Gist shared that Carver Middle School is beginning the naming process for their school gymnasium and that there would be more information to follow. Dr. Gist acknowledged Juneteenth and spoke about the complexity of Juneteenth to celebrate freedom, acknowledge history, reflect on the nation's progress, and be sobered and clear on the work that needs to be done. She also announced the Pride Parade happening on Saturday, June 24, 2023.
