REGULAR BOARD MEETING:

Board Members Present: Carl Conroy, John Hoctor, Deborah Heart, Virginia Amidon, and Mark Heid, Superintendent. John

Miller was absent.

Others Present: Kay Hill, Lori Hackbarth, John Westerman, Andy Maheras, George Miner, Darcie Reed, Barb

Stout, Tamara Johnson, Janet Gilliam and Mrs. Walker.

Call to Order: Mr. Conroy, Board Chair called the meeting to order at 7:00 p.m. He welcomed guests and led

the flag salute.

Agenda Changes: Add Item I-2d-hire all certified and administrative staff for 2014-2015, add item I-2e-hire all

classified and non-bargaining staff for 2014-2015 and add item I-2f, hire all extracurricular staff for 2014-2015. Mr. Conroy moved to approve the agenda additions if there were no objections;

motion carried.

Approval of Minutes: Ms. Heart moved to approve the minutes of July 28 and August 4, 2014. Mrs. Amidon seconded.

Motion carried.

Financial Report: Mrs. Hill reported on the most recent financial report as follows:

General Fund balance is \$957,950.26 Capital Projects Fund balance is \$77,886.03 Debt Service Fund balance is \$13,528.29

ASB Fund balance is \$157,280.00

Transportation Vehicle Fund balance is \$87,119.39 Knosher Scholarship Fund balance is \$30,095.48 Johnson Scholarship Fund balance is \$50,401.79

Payroll: Payroll for July 2014 was \$681,785.91. Warrant No's. were 97955-97996.

Payment of Bills: Ms. Heart moved to pay the August 2014 General Fund bills for \$101,557.99 (Warrant No's.

97997-98069) and the August 2014 ASB bills for \$4,205.89 (Warrant No's. 9257-9266). Mrs.

Amidon seconded. Motion carried.

Discussion: Mrs. Walker asked to speak at the board meeting; she announced her support for Mr. Dumolt as

the next head wrestling coach for Goldendale High School.

Information: None.

Principal Reports: Mr. Barta, Principal at Goldendale Middle School reported that four new teachers attended a

recent training on the evaluation tool. He noted that a parent/athlete meeting was well attended

by over 200 people.

Mr. Westerman, Principal at Goldendale High School reported that many training sessions are ongoing that include evaluation, discipline, Pro-Active coaching; he noted that it will be different

and new to have a remote counselor this year.

Mr. Maheras, Vice-Principal at Goldendale High School was introduced and welcomed; he noted

that he and Mr. Barta are working together on the District Safety Plan.

Mr. Miner, ESD 112 Special Programs Director reported that he will be working on improved communications through the district, setting staff expectations and provide staff training.

Board Comments: Mrs. Amidon and Mr. Hoctor welcomed the new staff and wished them a good school year. Ms. Heart noted that students she has been in contact with are excited to return to school. Mr. Conroy noted that the district was fortunate to find good employees at such a late time this summer and enjoyed the community involvement in the hiring process.

WSSDA/Leg. Report: Ms. Heart reported that it is important for the Board members to review the proposals for the September Legislative Session so that she can represent the Board's wishes when voting on these

measures. The proposal report will be out in late August.

Superintendent's Report: Mr. Heid reported that many superintendents have been visiting our legislators about school

issues; the ESD has hired a lobbyist to represent school needs in Olympia. The intercom & bell systems at the middle school and high school have been installed, the stadium bleacher flooring has now been enclosed for safety purposes, a new sidewalk has been created from the ticket booth to the stadium for improved handicap accessibility; the gym floors have all been resurfaced during the summer break, a boiler repair was made at the high school, the

well/sprinkler system required repairs this summer and the roof on the baseball field concession

stand will be repaired soon.

Mrs. Amidon seconded. Motion carried.
