Social and Psychological Services Update: Dr. Janelle Porter

- 1. Reviewed sample policies from AHA and DHSS/ MSBA and/or DESE.
 - Met with Assistant Superintendent overseeing behavior including vaping/ tobacco use.
 - Working on more specific details for interventions and planning to support the schools
 - Looked at the Code of Conduct to alter from exclusion to remain in school
 - Stipend of \$4,000.00 if enacted by end of June 2023 from American Heart Association
 - NKC Schools does not have If This- Then That policies allowing the District to address issues on a spectrum of events
- 2. Regularly occurring reviewing of the referral process
 - Creating a plan to share those across the district
 - Also increase communication with community regarding their resources available
- 3. Continue to assess for more to be included.

Health Education Curriculum Resources Update- Kenneth Clemens

1. Health teachers are getting more resources, links, names of potential guest speakers, etc.



- Anila Deliu addressed the elementary and secondary Professional Development Day and provided resources
- Tri County did the same with mental health and suicide resources
- Professional Development (PD) day evaluation reflected appreciation and benefit of resources
- Plan to add those resources into the curriculum
- Tri County has a new position open for a classroom health educator who will be able to go
 into the schools
 - Look forward to creating PD Feedback regarding the resources that are useful, not used,
 - Anila was invited to attend the next PD day for Health Teachers to get feedback

Health Services Update- Shannon Tilsworth

- 1. Community Partnership with Liberty Hospital and their Clinical Instructors allowed the Health Services Department nurses to attend an all-day Competency event in the Simulation Lab during the last Professional Development day.
 - a) Partnership with North Kansas City Hospital to obtain Narcan for each District building
 - b) Community Partnership with Liberty Hospital also resulting in Dr. Dustin Miller as the Medical Advisor for the NKC Schools Health Services Department.
 - a. Reviewing procedures to ensure evidence-based
 - b. Standing Orders for emergency medications will also go through Dr. Miller now
 - c) Swope Health Services will be at the Early Education Service Fair next week. Goal is to identify those students and families without a primary medical care home and refer to Swope to establish a regular medical provider for the whole family. Have not yet specifically worked on this but there are changes coming.
 - d) Immunizations addressed within the WSCC model

SHAC website: SHAC is mentioned in Board of Education policies and now has public facing information on the District's website, under the health services webpage.

Comments/Ideas/Suggestions:

Erin Gabert asked for the Roster for everyone on SHAC

Diane shared that Tri County MHS is piloting a vaping education at NKCHS to be used with students caught in violation and during ISS and follow up.

- 40 licenses ordered the first time around
- 8 components and each component take approximately 45 minutes to complete
- Must have 80% score before the curriculum allows the student to move to the next component
- Receive an "exit ticket" through VapeEducate

How to get more parents involved in SHAC

- Goal is to have 5-6 or more parents involved
