



# *Folsom Cordova Unified School District* **New Elementary Student Registration** **2023-2024**

*Online Enrollment Begins February 1<sup>st</sup>*

Welcome to the Folsom Cordova Unified School District! If you are new to the Folsom Cordova area and have a child entering grades Kindergarten-5th who will be attending our schools for the first time, it is very important that you go to your home/neighborhood elementary school to fill out the “Elementary School Pre-Enrollment Information Sheet.”

Transitional Kindergarten families may enroll directly at their home boundary school.

The child’s parent/legal guardian **must** fill out the Elementary School Pre-Enrollment Information Sheet. The following items are required in order to begin the registration process:

**Ed Code 48002** states that any of the documents listed proof of age is acceptable -

- Certified copy of birth record or statement by the local register or county recorder certifying birth date
- Baptism certificate duly attested
- Passport
- An affidavit of the parent, guardian, or custody of the minor
- Or any other means of providing the age of the child as proscribed by the governing board

**Immunization Records:** Please bring your child’s immunization card into the office for copying.

**Verification of Residency as defined Ed Code 48204.1 (but not limited to):** Utility Service Contracts, statements, payment receipts, Government Documents, Driver’s License, or non-government issued photo ID, Voter Registration, Property Taxes, or Pay Stub, declaration of residency, or correspondence from a government agency may be submitted.

- o If you do not have Verification of Residency in your name, an **Affidavit of Residency** must be completed by the resident whose name is on the SMUD or PG&E utility bill at the time of enrollment. The Resident must provide their utility bill and photo ID or non-government issued photo ID at the time of Verification completion.

**Custody Papers:** Relevant if applicable. Please provide us with a court stamped copy.

**In order to complete your child’s Transitional Kindergarten and Kindergarten online registration process we also need the following documents:**

- **Report Health Examination for School Entry:** This is valid for six months before Kindergarten through the third month after 1<sup>st</sup> grade begins. If your doctor performs a physical prior to entry in Kindergarten, please have this form completed and returned to the school. It will be kept in your child’s file and will meet requirements for entry into the first grade.
- **Oral Health Assessment:** This form is only needed for incoming Transitional Kindergarteners, Kindergarteners, and 1<sup>st</sup> Graders. Please have your child’s dentist complete the form and return to school by the end of your child’s first year of public school.

Please return all completed forms and supporting documents to the home/neighborhood school office.
