Describe how you will ensure continuity of instruction for students who may miss school due to illness.	Jefferson High School will dedicate time and effort to ensure that students who miss school due to illness will not fall behind their fellow classmates. This time and effort will be determined on a case-by-case basis by the building principal, assistant principal, and the counselor. Input will be gathered by the student's parents, school counselor, school nurse (absence duration), student support specialist, and building principal to develop a streamlined plan for the student.

Jefferson High School has a student care team, led by the building principal, to examine and implement a plan for any student/family who needs additional support or have been disproportionately impacted by communicable disease. Jefferson High School's processes are both thorough and streamlined, with attention given to each student's needs. We use a continuous improvement plan of design, plan, implement and reflect to make sure that our plan is refined and effective.

Implementing mitigation activities, responding to periods of increased transmission, resuming baseline level mitigation, and debriefing actions to improve the process

Planning for and implementing proactive health and safety mitigation measures assists schools in reducing communicable disease transmission within the school environment for students, staff, and community members. Communicable disease, including norovirus, flu and COVID-19, will continue to circulate in our communities and our schools. Schools will utilize different mitigation measures based on local data, and observation of what is happening in their schools (e.g., transmission within their facilities and communities.) Immunizations	CDC, OHA, and ODE recommend COVID-19 vaccination for all eligible individuals. Jefferson School District will not offer COVID-19 vaccine clinics, but we will continue to advertise vaccination opportunities for our staff and community as it becomes available. Immunizations are required by law for children in attendance at public and private schools, preschools, child care facilities, and Head Start programs in Oregon. Nearly every place that provides care for a child outside the home	
Face Coverings	requires shots or a medical or nonmedical exemption to stay enrolled.Face coverings for staff, students and visitors at Jefferson High School are optional.	
Isolation	Individuals who report or develop symptoms at Jefferson High School will be isolated in a designated area in the building, with adequate space, and symptom monitoring by a school nurse, other school-based health care provider, or school staff until they are able to go home.	
Symptom Screening	Staff and students who come to school sick or develop symptoms while at school will be isolated in a designated area until they can leave school (employees), or until their parents can pick them up. Students and/or staff showing signs of COVID-19 will have the option of being screened (students with parent permission only).	
COMP 10 Dis su estis Testis s	Jefferson High School will not take part in OHA's diagnostic testing program offered to K-12 schools in Oregon.	
COVID-19 Diagnostic Testing Airflow and Circulation	JSD and Jefferson High School will continue to ensure effective ventilation and improved indoor air quality. The continued focus will be to increase the amount of fresh, outside air that is introduced into the system; exhaust air from indoors to the outdoors; and to clean the air that is recirculated indoors with effective filtration methods.	
Cohorting	Cohorting will be informal but managed by the JHS student's schedule. Marion County Public Health no longer requires contacting students or staff members who are in close contact with a known COVID-19 positive case	
	Physical distancing will be encouraged as necessary.

Hand Washing	Regular hand washing is one of the best ways to remove germs, avoid getting sick, and prevent the spread of germs to others. Washing hands can keep you healthy and prevent the spread of respiratory and diarrheal infections from one person to the next. OHA and ODE strongly advise that schools create protocols and systems to ensure access to soap, water and alcohol-based hand sanitizer with at least 60% alcohol at key times and that schools prioritize handwashing with soap and water students, or staff use the restroom. JSD is committed to containing the spread of germs by providing plentiful access to soap, water, and alcohol-based hand sanitizer.	
Cleaning and Disinfection	Our custodians will continue to use a rigorous cleaning and disinfecting routine throughout the school day in an effort to mitigate the spread of any illness.
