PRINCIPAL'S MESSAGE

Kingswood PreK-8 is a school located in the heart of Citrus Heights, CA. We are a school full of dedicated and talented staff members who work to make sure that all children learn their grade level standards in a safe and caring environment. Our school emphasizes literacy, mathematics, science and technology along with the San Juan Unified School District's Board-approved character traits of respect, responsibility, honesty, caring, cooperation, and courage. We pride ourselves on being a school that is highly collaborative and committed to the high achievement of every student. To support our English language development program and students, we have regular ELAC (English Learner Advisory Committee) meetings, provide co-teaching between general education teachers and ELD teachers, and set aside collaboration time for general education with ELD staff. We provide a deep infusion of science and technology into all our programs coupled with AVID (Advancement Via Individual Determination) strategies; we have music and physical education specialists who work together to provide rich physical education and performing arts experiences for all children.

MISSION STATEMENT

Kingswood's mission statement was developed collaboratively by staff, parents, and community members and provides an overview of the school's unique identity, goals for students, and the strategies needed to achieve those goals. This statement was developed in 2010 and adjusted by the school community in 2017 to include the schools focus on becoming an AVID site.

The mission of Kingswood PreK-8 is to provide a premier school of academic excellence while engaging all students and inspiring them to become twenty-first century learners and successful members of our society through innovative AVID and student-focused instruction in a safe, collaborative, and caring environment in partnership with our families and diverse community.

SCHOOL PROFILE

Kingswood Elementary is one of eight PreK-8 schools in the San Juan Unified School District.

Kingswood's staff utilizes state and district adopted curriculum aligned to California Content Standards in all subject areas and provides intervention and extension support to English language learners, academically gifted students, and special needs students. Kingswood strives to meet the needs of all students within their K-8 program through a comprehensive approach to instruction and services including the following:

- Elective courses are uniquely designed through teacher expertise and collaboration to provide students with a rich elective program
- AVID (Achievement Via Individual Determination) is a focused K-8 program. Lessons, classroom structure, and procedures are delivered through the AVID lens and using AVID strategies.
- AVID (Achievement Via Individual Determination) is offered as an elective in our middle school program and is a base for our intermediate grades' program as well.
- Step Up to Writing is an effective, multi-sensory writing strategy that improves writing, reading, listening, speaking and thinking.
- PBIS (Positive Behavior Interventions and Supports) is a school-wide positive incentives program that provides pre-teaching and re-teaching opportunities for school rules and procedures, positive recognition for students following rules and a team of certificated and classified staff who meet monthly to provide professional development and platforms for discussion to create a cohesive school behavior plan.
- School-wide infusion of technology including wireless internet access, portable Chromebook labs, iPads, Smart TVs, and interactive whiteboards.
- Choir, band, and general music instruction (using a developmental approach used in music education) are additional music options.
- Middle school students participate in our middle school sports program: girls' volleyball, boys' and girls' basketball, cross-country, and track.
- School Site Council, ELAC (English Learner Advisory Committee), and parent coffee chats provide leadership opportunities for parents and staff.
- Character traits of respect, responsibility, honesty, and courage are integrated into everyday instruction.

Additionally, Kingswood engages partners to support student learning including: California State University, Sacramento Professional Development School, The City of Citrus Heights, Sayonara Youth and Family Center, Target, Office Max, Citrus Heights Chamber of Commerce, Heights Church, and the Citrus Heights City Council.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Kingswood School, originally constructed in 1960, was modernized in the 2000-2001 school year. During the summer of 2010, a portable bathroom and an additional portable classroom were delivered to house the expansion of the PreK-6 program into a PreK-8 program. Currently, there are enough classrooms to house the student population. Site custodial staff clean the buildings, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Adequate parking for staff and visitors, driveway resurfacing, and repair/renovation of the portable classrooms continue to be a concern. The parking lot was resurfaced in summer 2007 by Deferred Maintenance. In 2012, 7 portable classrooms received new carpet. The school buildings, classrooms and grounds are safe, clean and functional. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the board's standards for custodial staffing and cleanliness. All classrooms and restrooms are cleaned daily. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in September 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

Statewide Assessments

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and

School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel. At least one drill is held each month.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats.

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
