School Profile

Green Oaks Fundamental Elementary is one of 41 elementary schools in the San Juan Unified School District.

The curriculum provided is aligned to the Common Core State Standards (CCSS) and supports cultural awareness through its diverse literature selections and other school activities. Green Oaks programs reflect the interests and needs of its students and the surrounding community.

- Green Oaks provides an enrichment program that includes pull-out opportunities for advanced students and allows for differentiated instruction for all students within the classroom.
- When allowed to volunteer, Green Oaks' parents volunteer in classrooms and assist the school an average of 200 hours per week.
- Intervention is provided, as needed, for students K through grade 5 through individual, small group instruction and teacher assistance.
- Performance opportunities are built into the classroom experience as well as various school-wide opportunities such as classroom/grade-level plays or musicals, band in grades 4-5, and choir in grades 4-5.
- Family activities include but are not limited to Back to School Night, Fall Social and Fall Performance, Book Fair, Talent Show, Art Night, Science Fair, Band/Choir concerts, and grade-level themed events.

Mission Statement

The mission of Green Oaks Fundamental Elementary, an open enrollment school of high expectations and shared responsibility between staff, students, and families, is to ensure all students reach beyond academic standards to achieve excellence, a love of learning, and integrity through quality instruction and collaboration in a highly structured, safe, nurturing environment.

In the 2019-2020 school year and prior to Covid 19 in the spring, Green Oaks had a 69% proficiency in ELA and a 71% proficiency in Math. We are continuing with implementation of our strategic site plan. We will also continue to use data to help guide our decisions in student learning. CAASPP testing resumes this year.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Green Oaks Elementary was modernized, and a new multi-purpose room was added during the 2000-2001 school year. The scope for modernization included: roof/repair or replacement, interior and exterior painting, window system replacement, energy-efficient lighting, heating and cooling system upgrade, new doors with handicapped accessible hardware, restroom restoration, electrical infrastructure upgrade to provide for internet, cable, telephone, new fire, intrusion and intercom system, throughout the school. All temporary buildings have been replaced with permanent structures, including a new multi-media center housing the library and computer lab. In 2009, a complete major landscape and irrigation project was completed with Measure J funding.

Currently, there is sufficient space to house the student population. Discovery Club shares a room with a fourth grade classroom. There is a site custodial staff that cleans the building, along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Field repair and irrigation system retrofit continue to be a concern.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities. In November 2015 the school installed a cross-country track to increase physical activity for students.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. 2022-23 Opportunities for Parental Involvement

Parent participation is a major component of the fundamental philosophy. In addition to participating in their child's classroom experiences, parents participate and support the school in a variety of ways including helping teachers with "at home" projects, special events, correcting papers, and tutoring.

A strong Parent Teacher Association (PTA) at Green Oaks enhances the school's family atmosphere through many enrichment programs, including art night and the Fall Social. The PTA supports the teachers and classrooms with funds to purchase supplies and materials that might not be available through the regular funding sources. Additionally, the PTA provides support for the library, computer lab, and cultural assemblies.

Communication between the school and the parents occur through weekly Principal Announcements, classroom newsletters, and weekly academic and behavior reports. Parent education opportunities are available through the school library and the many courses/speakers offered throughout the year.

School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
