SCHOOL PROFILE

Carriage Elementary is one of 41 elementary schools in the San Juan Unified School District. Carriage Elementary is a kindergarten through 5th grade school located in Citrus Heights, California serving approximately 450 students. We at Carriage believe in an environment that promotes academic success and positive self-esteem while valuing individual differences. Students are expected to be safe, be respectful, be responsible, and be good communicators with others. Through the use of positive reinforcement and consistent modeling, we are shaping our students into becoming model citizens.

We at Carriage believe that the administration, the teachers, our parents, and the community must work together in order to complete our mission of academic excellence and model citizenship for students. Teachers are professionals who strive to be cooperative, flexible, communicative, and supportive. Parents strive to create a supportive learning environment in the home. By working together with families and the community, we provide an atmosphere where students have an opportunity to develop to their fullest potential.

Our school programs are used to provide academic growth, enrichment opportunities, and extension activities for our students and for their families. Art, music, and physical education are taught by specialists throughout the day. Each grade level organizes a musical production throughout the school year. This gives the students an opportunity to demonstrate their academic and content knowledge through alternate expressive means. Bridges After-School is a program that provides homework assistance, recreation, technology experience, and learning centers. Students who are designated as Gifted and Talented Education students (GATE) are given the benefit of an educational program designed to suit their capabilities and are encouraged to extend their learning beyond the grade level requirements. The district offers parenting courses so parents are able to refine their parenting skills. These courses are available on the district website.

Carriage also provides programs to meet the needs of learners who require individualized educational plans. We have two Special Education Teachers with self-contained ASD classrooms, as well as one Resource Teacher, as well as one full time Resource Instructional Assistants. We have one Inclusion Teacher who supports students who are fully mainstreamed with shared instructional assistant support. The Special Education Department supplements the regular education program and supports the district's mission by providing the best instruction and opportunities to improve academics and develop character for all students.

Carriage has a population of English language learners speaking a variety of languages. Carriage has on staff an English Language Development Teacher who works with our English learners in small groups according to skill level. We place our English learners in general education classrooms where the teachers deliver differentiated instruction on a daily basis.

Carriage Drive Elementary was named a California Distinguished School in 2010.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Carriage Drive Elementary School opened in 1986 and is one of the newer schools in the district. The site is evaluated yearly on the condition of the roofs, heating and air-conditioning system, paint, electrical infrastructure, window system leakage, and handicapped accessibility. Currently there is sufficient space to house the student population. Site custodial staff clean the buildings along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. Field repair and irrigation system retrofit continue to be a concern. In 2005, under the Measure J Bond, new gas service was installed to support future heating and air conditioning upgrades. Measure J replaced the roofing for the entire site in 2004.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in October 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities. In the summer of 2019, Carriage received updates to its campus. There was updated air conditioning, painting, new flooring in the MP room, and new carpeting in all classrooms. All the sidewalks and parking lots are new within the last four years.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
