Mission Statement

The Charles Peck Elementary School mission is to work collaboratively with staff, parents, and community members in providing all students with a foundation of skills, knowledge, and attitudes that will enable them to be motivated learners who reach their individual potential. High expectations for students reflect a school-wide belief that all students will achieve when provided the appropriate instruction in an encouraging and safe environment.

Charles Peck Elementary is one of 41 elementary/K-8 schools in the San Juan Unified School District. The percentage of students that qualify for free and reduced lunch is 80%. We are a Community Eligibility Program site, so all of our students eat for free. The curriculum provided is aligned to the Common Core State Standards (CCSS). The school supports cultural awareness on a daily basis through academically and culturally responsive instructional practices and other school activities. At Charles Peck, we believe in educating and supporting the whole child - academically, socially, and emotionally.

Our goal at Charles Peck Elementary School is to provide all students with a foundation of skills, knowledge, and attitudes that will enable them to be motivated learners who reach their individual potentials. High expectations for students reflect a school-wide belief that all students will achieve when provided the appropriate instruction in an encouraging and safe environment. Title I federal dollars fund a full-time Intervention Teacher, a full-time counselor, professional development support, release days for staff development and collaboration, curriculum materials and supplies as well as technology upgrades. We have two additional intervention teachers; one is funded using the ELO Grant and the other is funded with the ELO Grant and Title 1 dollars. All classrooms have digital presentation ability and all classrooms are equipped with Apple TV systems and K-5 students have access to iPads, desktop computers and Chromebooks. This year a .5 ELD Specialist supports English Language Learner students within the classroom and small groups.

The following programs support the grade level standards-based instruction at Charles Peck: Benchmark ELA for reading and writing, Scholastic Guided Reading, Okapi leveled texts, Envision Math, i-Ready Reading & Math, Read Naturally, Raz Kids, SIPPS, LLI Kits, GLAD strategies, Lexia, Heggerty Phonics/Phonemic Awareness, and other research-based practices. PBIS (Positive Behavior Intervention Support), along with A Little Spot of Emotions/Feelings, Strong Kids, Strong Start and Zones of Regulation to promote positive behavior choices through explicit instruction, positive recognition and consistent natural consequences. We work closely with support staff from the Student Support Center to provide multi-tiered intervention based on data and frequent progress monitoring. The Bridges After-School program provides child care, games and activities until 6 PM. The School Safety Team attends meetings, conducts emergency drills and collaborates together in establishing site safety procedures.

We use the Common Core State Standards and ongoing assessment to guide our instruction and communicate academic growth to families throughout the year. We encourage a college-bound culture with our students and promote positive character traits of safety, respect, responsibility, citizenship, fairness, and friendship as a school focus.

We value your support as a parent/guardian and partner in educating our students and encourage open communication and collaboration between families and school. We encourage parents/families to partner with us in promoting a positive learning environment here at Charles Peck School.

2022-23 Quality, Currency, Availability of Textbooks and Other Instructional Materials

San Juan Unified held a public hearing on September 28, 2021 and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. School Facility Conditions and Planned Improvements

Charles Peck, originally constructed in 1961, was modernized during the 2000-2001 school year. Currently, there is sufficient space to house the student population. Site custodial staff clean the buildings along with district support for major/minor repairs. The district provides gardening and landscape services on a regular schedule. Regular fire/emergency drills are held, and badges are required for all visitors and personnel. In 2009, the entire school had the exterior painted through Deferred Maintenance Funding. Using Measure J funds, a site-wide landscape and irrigation project was completed Winter 2013. This included ornamental fencing, sidewalks and ramps, storm drains and sewer lines, grass, plants and trees. All restrooms site-wide are being reconfigured and renovated using Measure J funds. This project is scheduled for completion January 2014. It includes all plumbing, fixtures, partitions, floors, walls, path of travel and upgrades to meet ADA requirements.

The Board of Education and the Superintendent's policy is to ensure that all students are provided with a safe and well-maintained learning environment. The board approved resolutions in 1998 and 2002 to adequately fund maintenance activities and preserve the repairs and improvements funded by two facility bond measures. The school buildings, classrooms and grounds are safe, clean and functional. An inspection of the facility was conducted in August 2020 and determined that there were no unsafe conditions that required emergency repairs. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A computer automated work order process is used to ensure efficient service and that emergency repairs and health and safety repairs are given the highest priority. The Board of Education has adopted cleaning standards and custodial staffing requirements for all schools in the district. This school meets the Board's standards for custodial staffing and cleanliness. The school's custodians are trained in the proper use of cleaning chemicals and Integrated Pest Management techniques. They are managed day to day by the Principal with assistance from the district's maintenance department. The district participates in the State School Deferred Maintenance Program, with funding allocated for major repair or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Annually the district budgets \$2 million dollars for deferred maintenance activities.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

2022-23 Opportunities for Parental Involvement

There are many ways that parents can become involved in the school community. The Charles Peck School Site Council (SSC), comprised of members of whom half are parents, takes an active role in developing and monitoring the School Improvement Plan. The focus of improvement is developing students' literacy and mathematical ability, the use of technology, the fostering of a positive learning climate, and ensuring equity for students, especially those that have been marginalized. The Charles Peck Newsletter is a bulletin sent home to inform parents about school activities and events, as well as parent education opportunities. Examples include safety information curriculum support, and effective routines, and opportunities to provide feedback and voice. Classroom teachers regularly send home newsletters and/or informal progress notes. Parents are informed about their children's accomplishments through formal and informal parent conferences, progress notices, report cards, telephone calls, emails, and notes. Other communication platforms utilized to support parent/school engagement are Class Dojo and Class Tag.

Parents are encouraged to volunteer their time or talents supporting school events such as the primary 100 Day activities, Family Nights, ongoing SSC, fundraisers, Parent Teacher Committee (PTC), and other school activities. Our monthly ELAC (English Learner Advisory Committee), Parent/Principal, and School Site Council (SSC) meetings along with Family Engagement Events, including The Neighborhood Learning Project focus on academic achievement for all students, providing a variety of support resources, and building positive character traits. Parent/family involvement and engagement will continue to keep our professional learning community on track to achieving each step outlined in our strategic plan. During the COVID-19 pandemic, volunteering opportunities are limited to support field trips. As guidelines change that allow for parents on campus and in class, parents will be informed of opportunities to volunteer on site.

School Safety Plan

San Juan Unified School District emphasizes school safety and understands its importance in helping to achieve the academic success of its students. In accordance with the California Education Code, each school site must complete and maintain a Comprehensive School Safety Plan, to be reviewed and updated annually. The plan includes a review of safety data for the campus, safety policies, critical incident response & management information as well as emergency procedure information including those pertaining to incidents involving fire, earthquakes, intruders and other dangers. The review and update of the plan is a collaborative process involving representatives from site administration, instructional staff, custodial & classified staff, safety personnel and parent representative who together comprise a site safety team. Finalized plans are posted to site webpages for public access and presented to staff during training and development days no later than March 1 of each year. A copy of the plan is available for review in each school site office.

Safety drills are held on a regular basis and in compliance with the California Education Code to include fire drills, earthquake drills and intruder drills. Drills are coordinated and monitored with the assistance of the trained district safety personnel.

Safety is a shared responsibility. Each school site is supported by the district's Safe Schools Team. The Safe Schools Team is comprised of personnel specifically trained to support and promote school safety, provide advice to matters involving student welfare, assist in the coordination of drills and provide safety training to students and staff. Safe Schools Team members, known as Community Safety Specialists work collaboratively with site administrators and safety committee members to build and strengthen a culture of safety as well as address specific incident needs. The Safe Schools Team members are further supported through developed relationships with local law enforcement offices including the Sacramento County Sheriffs Department & Citrus Heights Police Department. San Juan Unified maintains contracts with local law enforcement for the purpose of employing uniformed law enforcement officers to further enhance school site security for special events as well as in response to critical incidents and threats. .

Professional Development

Professional development is a key part of the continuous improvement process for educators. The goal of our quality professional development is to support the learning of teachers and paraprofessionals to positively impact student achievement. Annually, teachers and site administrators participate in professional development in a variety of opportunities. Seventy-five minutes per week are dedicated to staff collaboration and training planned by site leadership teams. The District also provides a cycle of continuous professional development for Administrators through Principal Networks as well as Leadership Academies.

The District provides professional development opportunities for teachers and administrators that support the implementation of Common Core State Standards in English language arts, mathematics, science, social studies, and the ELA/ELD Framework. Specific professional development initiatives include: Culturally Responsive Practices, Critical Literacy, TK-2 Reading, Supporting Independence and Engagement through Reading and Writing, Math to the Core, Expository Reading and Writing Course, and ELD Foundations. District departments, Center for Teacher Support, grant-funded projects, and the San Juan Teacher's Association sponsor additional training opportunities. Professional development opportunities are voluntary for teachers and are provided throughout the year in a variety of formats: during the school day, after school, on Saturdays, and during summer and vacation breaks. Many teachers and administrators also take advantage of opportunities with Sacramento County Office of Education, California Department of Education, the college/university programs, state/national education organizations, and private educational institutes.

What grounds the professional development in the district is the District Strategic Plan and the Local Control Accountability Plan. Professional Development is further determined using one or more of the following: (a) student achievement data, (b) staff survey data, and (c) district-identified goals. Professional development addresses the Common Core State Standards, teaching strategies, curriculum, assessment, technology, classroom management, safety, and leadership. Administrator training accompanies professional development in district focus areas, providing implementation support for teachers on site. Content-area coaches are available at some schools. Additional classroom support is provided to new and struggling teachers by consulting teachers from the Center for Teacher Support.

Paraprofessionals are encouraged to participate in professional development at the district and site level, and there are specific opportunities designed for our paraprofessionals to attend and be compensated. Specifically designed training is also offered to non-instructional support staff such as clerical and custodial staff that includes both operational and instructional topics.
