Mitigation strategies that funds will be used to purchase include increase products for sanitation and safety, Covid testing for staff and students, increased access to outdoor/indoor space with tent rental and building outdoor pavilion and purchasing pavers for atrium to increase square footage.

Funds will be utilized to purchase college tuition and supplies for dual enrollment classes to support student learning and offer additional access to college courses during summer months and evenings during the school year.

The LEA will also increase supports to learners with an additional CTE teacher, a bilingual classroom assistant, an additional teacher assistant, a bilingual school social worker, mentoring and guest speakers, an enrichment math program, need bars for Promethean boards, Powerschool training and eCollect software to keep track of student vaccination data, IEP Direct software to increase communication with parents and sending districts, and FM systems for students with attention and auditory processing disorders.
