WHEREAS, principals of Indigenous Peoples' heritage have led their schools with vision; and

WHEREAS, Indigenous Peoples have served the school board with distinction; and

WHEREAS, the Fairbanks North Star Borough Board of Education values the many contributions made to our community through Indigenous Peoples' knowledge, labor, skills, monetary contributions, and the deep cultural contribution that has substantially shaped the character of the City of Fairbanks; and

WHEREAS, the Fairbanks North Star Borough Board of Education opposes the systematic racism towards Indigenous People in the United States, which exacerbates disproportionate educational opportunities; and

WHEREAS, the Fairbanks North Star Borough Board of Education promotes the closing of any achievement and equity gaps for Indigenous Peoples through policies and practices reflecting the experiences of Indigenous Peoples, ensuring greater access and opportunity, and honoring our region's indigenous roots, history, and contributions; and


