Any additional terms and conditions, which may be subject of negotiation, will be discussed only between Los Lunas Schools and the Offeror selected from the final agreement and shall not be deemed an opportunity to amend the Offeror's proposal. Upon approval of award, the Procurement Manager and Evaluation Committee may negotiate the final contract(s). If the District and Offeror cannot reach an agreement on the contract terms and conditions, the District may terminate negotiations with the first ranked Offeror and then go to the second ranked Offeror and negotiate a contract. If the second ranked Offeror cannot reach an agreement, the District reserves the right to cancel the procurement and re-advertise the solicitation.
