Additional Required Documents

____ Original Certified Birth Certificate (Hospital birth record/Baptismal Certificate will not be accepted)

 ____ Guardianship papers – if someone other than the parent is enrolling the student. **For students whose parents reside in Illinois, this involves filing for guardianship through the court system.**

For TRANSFER students - documents that must be obtained from Previous School

1. If transferring in-state - ISBE form/Out of state transfers require a Letter of Good Standing on school letterhead
2. An unofficial transcript.
3. Current class schedule and grades in progress if transfer is occurring during the school year.
4. Current IEP/504 Plan for any student receiving Special Education Services at their previous school.
5. A **State of Illinois School Physical Exam** including immunizations with the physician’s signature and address. Out of state transfers, require an Illinois school physical exam and vision exam.
6. **For incoming Freshmen** – 8th grade report card & Diploma
7. **Seniors Only** – Meningitis Vaccination – Under the provisions of Illinois law, all 12th grade students are required to show documentation of receiving 2 doses of the meningococcal conjugate (meningitis) vaccine.
