I am incredibly disheartened to hear that this democratic body is proposing a financial stipend for members and would be interested to hear which board member proposed such a thing as well as their reasoning. When running for school board all members were aware of the position and what it entailed, they were voted in by the constituents of the district to represent the students and parents of said districts. This appears incredibly disingenuous at best and exploitative at worst. My child attends Brattain online and has since Kindergarten as I, myself, have health complications. The program ran very well through Covid and I've always been impressed by the teachers and their ability to maintain a classroom and devote time and attention to each student and their needs. However, each year the district has seemingly had a poor retention rate or alternatively has dropped teachers in order to save money. Last year, my student was in a 2nd-3rd grade blend and that worked well as my 2nd grader was in advanced placement. This year, my student's classroom was originally 1st-3rd grade blend and due to your school district's inability to invest in online learning and teacher retention my student's teacher is now teaching 1st-6th grade. The level of irresponsibility and disservice this does to both the students and teacher is immeasurable. As a result, my child's school day has changed from 8:30am-2:50pm to 8:30am-11am. Is this a responsible way of teaching? Is this serving the community? What research has been done on outcomes of shortening the school day to this degree and how well do you suppose a single educator can teach responsibly with this variation of grade levels simultaneously? I am writing this comment not as a SPS employee, but rather as a fan and official of volleyball. This past year, Springfield High School hosted the 3A and 4A state tournaments for high school volleyball. The tournament was a success and will be returning to SHS November 3rd and 4th, but I worry this year might be the last.

The SHS gym is uniquely set-up to allow matches to take place simultaneously while also providing warm-up courts in the auxiliary gyms. This makes SHS the only school in the area that could feasibly host the state tournament. Feedback from teams and officials from last year's tournament was overwhelmingly positive about the gym, the organizers and the practice spaces. However, feedback about the facilities outside of the gym was negative and puts the future of state tournaments taking place at SHS and the Eugene-Springfield area at risk.

The reason I am writing this comment is to bring attention to the fact that having the state tournament in Springfield is a great way to highlight the positive aspects of our community. Teams and spectators come to Springfield from all over the state and we need to make sure that they have a positive experience, so we can ensure that SHS remains the host for years to come. I know we are extremely short staffed in terms of custodial staff and as a THS employee I know how hard they are working and asking them to take on additional duties is probably not feasible. I hope that the board can allocate additional resources leading up to the tournament or help organize volunteers to get SHS ready for the tournament weekend.

Last year 20 lane county officials helped with line-judging, the scorebook, libero tracking and scoreboard as well as setting up a hospitality room for the officials traveling from all over the state. And I know just as many will help this year and will work tirelessly to make sure the tournament runs as smoothly as possible. If we as officials can help out in any way, please reach out to discuss further the ways that we can make sure SHS remains the state tournament host for years to come.

To the members of the board:

I am writing to you this evening regarding the condition of the soccer fields at Thurston Middle school and Briggs Middle school. I am writing as a parent, as a U11 soccer coach, and as a Physical Therapist who treats sports injuries daily.

My soccer team is practicing currently at Briggs Middle school where the size of the holes is enough to catch a child's foot and sprain an ankle. There is nearly no grass and my players have complained of sore knees after running on the dry, barren ground. There is a large mound of dry dirt that is directly in front of the goal box that makes trying to accurately shoot the ball nearly impossible. The area where the goalie stands has large cracks and grooves that catch her cleats each evening. We have had 3 sprained ankles so far this season on just our practice field. When a girl falls down, her skin is ripped up since there is no grass to cushion her fall. The ground is so hard and void of grass that the ball moves so quickly that they cannot control it or catch up to it. They may as well be playing indoor soccer! I have many girls that are new to soccer this season and teaching ball skills is very challenging when the ball bounces so high off the firm dirt and rolls so rapidly. It is really quite appalling that this is the condition of the field chosen for U11. I am coming from LYSA that played at Petersen Barn with lush grass. We practiced at Monroe Middle where we could teach true ball handling skills in grass. My 2nd grade daughter practices at Cal Young for Kidsports and plays games at Gilham. The comparison photos make Briggs look ridiculous.

Good day and hello Honorable Members of the School Board for Springfield Public Schools,

News outlets report that teacher morale is at an all-time low. It certainly is true that many of the problems related to teacher morale that we have in our district are ones that can be found in other school districts. It is also true that some of the solutions to these problems are ones that must happen locally. We submit for your consideration some thoughts about something that could be done in the short term to send out a positive message to teachers. In these difficult times, we teachers desperately need a morale boost.

When this district implemented changes due to the pandemic, one of the first things that happened to teachers and other school staff was that we were required to empty our classrooms and offices of many personal items, things that we used to make our "homes away from home" more comfortable for ourselves and our students. We hauled out the comfy student and teacher furniture, area rugs, house plants, and small personal appliances that made life easier and our classrooms more inviting. We did this at a time when we did not know much about the coronavirus and how it was spread.

When distance learning ended, we were anxious to restore our "homes away from home" as best we could. However, we quickly found out that this was unacceptable; in particular, having small personal appliances like mini-refrigerators or microwave ovens in the classroom was now forbidden. This seems odd when you consider that these things are fine in a college dorm room and are allowed in neighboring school districts like 4J, Bethel, and South Lane among others.

You might be wondering "what's the big deal - doesn't your school have these kinds of appliances that you can use in the staff room?" At this time, Page Elementary does not have adequate refrigerator space for *all* staff to store *all* their lunches as well as many other things that we want to keep cold like coffee creamer, drinks, condiments, salad dressings, etc. Our two refrigerators might be sufficient in a workplace in which people work on different shifts or can leave the building for meals, but not somewhere where nearly everyone is working at the same time. If there are special events in our building or leftovers from a staff event, there is simply not enough room in our school's refrigerators for everyone to store their lunches, cold drinks, condiments, etc.

Moreover, being a teacher can be extremely exhausting, and on many days, every minute of the half-hour we have for lunch is precious. There are times when we give up large chunks of our breaks to deal with student needs or issues, so the thirty-minute lunch may actually be closer to ten or fifteen minutes. We also don't have the luxury of leaving the building to grab lunch out like other district employees can. Since it is no longer permissible to have a small microwave in one's classroom, some of us have to get in line in the staff room in order to have a hot lunch. It can take nearly ten minutes to walk to the staff room, heat up lunch, and then return to eat in the classroom. Many of us prefer not to eat in the small staff room as it is a very poorly ventilated space in which the heat does not work properly. (Last year, there

were many days when the staff room would heat up to over eighty degrees.) Giving up a third of one's lunchtime in order to have hot food just isn't worth it.

As a result, many members of the Page staff have stopped trying to have a hot meal at school if it means going to the staff room to use the microwave ovens there. This is a shame, especially during the cold, winter months when so many student and teacher spaces in our very old building are not adequately heated.

Giving teachers and other staff the autonomy to make our "homes away from home" more comfortable and usable would tell staff that you want us here and you want us to be comfortable and to love being here. Rescinding these unwarranted restrictions would be an immediate, no cost (or very low cost) morale boost that would show that district leadership does have empathy for us. For years in this district, it was not a problem for building staff to have small personal appliances in their rooms.

Furthermore, at a time when this district is competing with neighboring districts for classroom teachers, it makes sense to be in line with what neighboring districts allow teachers to do.

We appreciate your hard work and your devotion to our district and public education in general. While we realize there are many important and complicated issues facing our district, retaining teachers needs to be at the top of the list. Rescinding the district policy that forbids something that was not a problem in our district in the past and is currently not a problem in many, many other school districts (and dorm rooms) throughout our country would be a step in the right direction.
