## REGULAR BOARD MEETING MINUTES BUDGET HEARING

Administration Building September 18, 2023 6:00 P.M.

The regular meeting of the Board of School Trustees of the Bluffton-Harrison Metropolitan School District was held on Monday, September 18, 2023, with all members present. Also in attendance were Dr. Brad Yates, Superintendent; Julie Meitzler, Assistant Superintendent; Tammy Mechling, Corporation Administrative Assistant; Jessica Bricker, Corporation Communications Specialist; Steve Baker and Rick Mettler, Administrators; Jinny Broderick, interested patron; and Holly Gaskill, News-Banner representative.

Prior to the regular meeting, Dr. Yates led the Board members through the Budget Hearing process. With no discussion forthcoming, President Holland asked for any public comment. Hearing no comments from the public, the Budget Hearing was adjourned at 6:02 P.M.

President Holland called the meeting to order at 6:03 P.M.

President Holland expressed appreciation Mr. Jim Bueter and the Band Boosters for providing a great event for twenty two (22) area bands to compete at the *Banks of the Wabash* and congratulated the BHS Girls' Golf Team for finishing 5<sup>th</sup> place at Sectional, with Emma Schwartz advancing to Regionals with a personal best score of 84. President Holland also thanked those in the community who assisted in bringing Cody Knuckles and John Humphries to speak to middle and high school students about addiction.

President Holland called for public comment from Jinny Broderick, who registered to speak prior to the meeting. Mrs. Broderick expressed her gratitude for the district's partnership with Park Center to hold the upcoming Mental Health/Suicide Awareness Walk at our stadium on September 30, 2023.

Minutes for the Regular Board Meeting held on August 14, 2023, were approved by consensus and appropriate signatures affixed thereon.

Vouchers for the period of August 15, 2023, through September 19, 2023, were approved by consensus and appropriate signatures were affixed on the voucher register.

The Fund Report for August was approved by consensus.

The Bank Statement for August was approved by consensus.

The Fund Transfer Report was approved by consensus.

Mrs. Meitzler reported on the BHES Preschool Paths to Quality Appreciation Award. The BHES Preschool was recognized with a \$500 one-time cash award for maintaining a Paths to Quality Level 3 status for at least five years.

Mr. Baker reported on the US News and World Report ratings for Bluffton High School, which ranks Bluffton High School among the best high schools in the State of Indiana and in the nation.

Dr. Yates presented information about the IDOE Excellence in Leading & Learning Award that was awarded to Bluffton-Harrison MSD.

Mrs. Meitzler reported on district communication, curriculum and instruction.

Dr. Yates reported on district projects, collective bargaining, Federal Accountability Report Cards, and the School Employees' Benefit Trust.

Dr. Yates thanked our school nurses Javon Steffen, Bethany Clem and Darcy Isch for preparing their annual nursing reports for the Board and for their service to our students and staff.

Dr. Yates reported enrollment numbers as of Friday, September 15, 2023. Our current ADM is 1,702 K-12 students.

Dr. Yates reported that the Middle School Roof Replacement and Improvements Project continues and the contractor has indicated substantial completion to be on September 30, 2023.

Dr. Yates reported the High School HVAC Guaranteed Energy Savings Project is complete with the only remaining phase involving the technical controls of the new system.

Dr. Yates reported there are no new updates on the School Safety Security Referendum.

Dr. Yates noted the Middle School Parking Lot and Tennis Court Improvements Project is nearly complete and the site improvements have dramatically improved the safety of student, bus, and parent traffic at our middle school during commute times.

The Board approved three resolutions to move forward with the High School Building Envelope – Roof, Walls, Windows, Canopies Project. On a motion by Mike Murray and second by Julie Thompson, the Board approved the Resolution Approving Form of Third Amendment to Lease as presented. The motion passed unanimously. On a motion by Trent White and second by Angie Sheets, the Board approved the Resolution Re-Approving Building Corporation as presented. The motion passed unanimously. On a motion by Bruce Holland and second by Julie Thompson, the Board approved the Resolution Determining Need for Project. The motion passed unanimously. The three resolutions approved are contained in Excerpts of Minutes from the Board Meeting in Correlated File #2324-08. The items approved tonight will be filed appropriately to continue the legal proceedings for the district. In addition to the legal process, the district has begun the design and planning phases for the project. Dr. Yates presented early graphic renderings of the high school generated by Elevatus Architecture. The proposed copy of the Third Amendment to Lease is enclosed in Correlated File #2324-09.
