ENSURING CONTINUITY OF EDUCATIONAL SERVICES

Students who must quarantine or isolate for COVID-19 related reasons will receive remote instruction aligned to in-person teaching and learning to the greatest extent possible. The district will work closely with families to provide internet connectivity and the necessary equipment for those families in need of assistance. When students are quarantined, parents should work to assist students at home with the following guidance:

Ethel A. Jacobsen: Preschool through Grade 2, students will receive materials to complete and the student will be allotted time, when they return, to complete any missing assignments. For periods of a longer quarantine, the student will receive teacher created packets and materials. The students will complete the packets at home and return them to the teacher after quarantine. There will be a remote check-in to assist the students during the school day.

Long Beach Island Grade School: Grades 3 through 6, students should follow the updates to the Google Classroom by homeroom teacher and/or subject area. Teachers will update assignments for students to work on learning experiences from home. Students will complete and submit assignments online or return items to the school after quarantine. There will be a virtual check-in to assist the student during the school day.

The district will determine the deployment of technology based on instructional needs. For students who do not have use of a home device, parents should contact ssmith@lbischools.org. A parent/guardian will need to sign a loaner agreement form for the school-issued device.

Considerations and procedures include:

- Classroom assignments and activities will be posted to Google Classroom.
- Teacher(s) will periodically check in with students accordingly.
- The parents/guardians of students who must isolate or quarantine due to an out-of-school COVID-19 related matter must contact the school's main office with their request for remote instruction and inform the health office. Upon review and approval of documentation (i.e. doctor's note or test results) pertaining to the out-of-school COVID-19 related matter by the health office, the student will receive virtual instruction as necessary. The teacher(s) will periodically check in with students throughout other portions of the lesson(s) accordingly.

- In the event that a classroom, school, or district needs to move to a complete remote learning environment, the students will follow the school schedule. All students will receive a Google Meet or Zoom link on the first morning of the remote session. Expectations for remote learning will be provided by the district and distributed to students via the classroom teacher.
