The Regular Meeting of the Board of Education of Orono Independent School District No. 278 was held on Monday, September 25, 2023 and called to order by Board Chair, Mike Bash at 7:00 PM.

5. - Superintendent's Report on Excellence

Dr. Flesher began her report with an announcement of eight National Merit Scholars - three Semifinalists and five Commended Scholars. These students in the Class of 2024 are recognized by the National Merit Scholarship Corporation for outstanding results on the PSAT/National Merit Scholarship Qualifying Exam taken last fall. Semifinalists are the highest-scoring entrants in each state. The nationwide pool of Semifinalists represents less than one percent of U.S. high school seniors. The Semifinalists are Jack Eugster, Emily Middleton and Walter Royal. Semifinalists will work with Ms. Brandy Randall, Orono's secondary Orono Challenge Coordinator, to complete an extensive application packet and move forward in the competition.

Commended Scholars this year are Leah Barry, Dexter Benson, Spencer Bowe, Alexander Engle and Joseph Mariani. These students will receive a Letter of Commendation from National Merit in recognition of their outstanding academic promise.

Next, Dr. Flesher highlighted Orono's Unified program, and noted that it has been instrumental in supporting the culture of inclusion and respect for students with and without intellectual disabilities. The program has provided opportunities for students to not only have fun and experience the joy of Special Olympics competition, but develop leadership skills, empathy, and trust. Dr. Flesher thanked Advisor Michelle Swenson for submitting a robust application to Special Olympics and helping the high school earn the national honor of "Unified Champion School." Orono is one of only a handful of schools in Minnesota to earn this designation.

Next. Dr. Flesher shared that homecoming is next week, October 2-7. In keeping with tradition, secondary schools will have dress-up days all week and other fun activities. Our elementary students will show their Spartan spirit on Friday. The parade is scheduled for 1 p.m. Friday and members of the community is welcome to attend. The Community Tailgate Party — co-sponsored by the Orono Foundation and the OHS Student Senate – is from 5-6:30 p.m. with food trucks and other family activities. The homecoming football game kicks off at 7 p.m. against the Providence Lyons. Tickets are on sale through our GoFan site.

Finally, Dr. Flesher concluded her report by sharing a fall sports update. The Spartans Football team is 4-0 on the season with their most recent win over Delano on Friday. The team is currently ranked #3 in the latest Class 4A rankings. The Girls Swim & Dive team has won their last three dual meets against Westonka, Waconia, and New Prague. They are currently ranked #3 in Class 1A. In their last meet, the Boys Cross Country team finished with a 16:51 team average, which was the fastest team average in Orono history. The Boys are currently ranked #5 in Class 2A. The Orono Boys Soccer team is still undefeated on the season, with an 8-0-2 overall record. They are currently ranked #2 in Class 2A.

Wendy Lundsgaard shared that she attended a meeting of the ECFE Parent Advisory Council, and noted that they are hard at work planning for fundraisers and events, and welcoming new families into the program.

Ali Howe did not have any updates to share.

Laura Wallander provided an update from the most recent meeting of the Orono Action Committee, where they began their discussion by refocusing on the purpose of their committee. Ms. Wallander also shared that the group is planning a breakfast this fall to keep lines of communication open with our local legislatures.
