Under Idaho public records law, Sinclair is requesting the following public records:

- All material provided to students relating to gender identity and sexual orientation.
- All material provided to students that includes the term "antiracism."
- All material provided to students that includes the term "drag queen."
- All public records relating to drag performances sponsored by Emmett Independent School District or held on school grounds.
- All materials provided to staff and students containing the term 'genderaffirming care.'
- All materials provided to staff containing term "restorative justice."
- All materials relating to district staff turnover.
- All materials relating to district graduation rates.
- All materials relating to student attendance.

Please note this request only pertains to the time period between January 1, 2022 and July 24, 2023.

The phrase "relating to," and all its permutations, when used in conjunction with this request, means embodying, recording, evidencing, summarizing, digesting, referring to, commenting upon, describing, reporting, listing, analyzing, studying, or otherwise discussing in any way a subject matter identified in this request.

This request should be interpreted broadly and in accordance with its plain language, rather than narrowly construed, and includes all emails and text messages, including communications on private devices pertaining to city business. If you are uncertain as to the scope of this request, please contact me for clarification.

If there will be any fees charged, please let me know before you fulfill my request. I ask that you include a detailed invoice, including the employee(s) who will be filling the request. If you deny any part of this request, please cite each specific reason and state statute that you think justifies your refusal to release the information.

In accordance with Idaho Code §74-103, this letter is in response to the public records requests received by the Emmett School District on August 14, 2023.

Due to the scope of your request, in accordance with Idaho Code §74-103, the District will require additional time to respond, especially if your inquiry extends beyond what is provided here.

The following is what we have compiled thus far:

Please note: Though I provide details for each question asked, many of these issues fall under the jurisdiction of Emmett School District's policy <u>2340</u> and <u>2340F</u>. This means that these controversial issues are NOT in our district curriculum. Should a teacher want to use supplemental materials mentioning such issues, they would need to go through the formal process of approval as outlined in <u>2340</u> and <u>2340F</u>. (I have included the links to those policies for your review.)

Here is more specific information relating to each of the issues you presented.

Gender Identity and sexual orientation

All material provided to students relating to gender identity and sexual orientation.

Response: Gender Identity and sexual orientation is not a part of any materials provided to students. If more specific information is needed in this area, please provide a more detailed request.

Antiracism

All material provided to students that includes the term "antiracism."

Response: Sifting through all books and materials for the term antiracism would require a significant amount of staff hours and work. If interested in pursuing this, please provide specifics so we can narrow our search (grade level, subject, fiction vs nonfiction materials etc.) We will provide you with a cost estimate to complete such a task.

Drag Queen

All material provided to students that includes the term "drag queen."

Response: The district is not aware of any materials provided to students that use the term "Drag Queen." The possibility exists that the term may be used in the context of fiction material at the high school level. If you would like all such materials analyzed for this term, please provide more specific information to aid in our search. We can provide a cost estimate for the hours. Since the term is not a part of our curriculum, the final result after the hours and cost is likely to be a count of zero. Considerable cost and hours may be required for full verification.

Drag shows

All public records relating to drag performances sponsored by Emmett Independent School District or held on school grounds.

Response: No drag performances have been sponsored by the Emmett School District or on its Grounds.

Restorative Justice

All materials provided to staff containing the term "restorative justice."

Response: Our staff at Black Canyon High School (Alternative School) has received training on restorative justice. Please provide more details as to the information sought and if you seek the actual training materials containing the term or reports of how and if and how it may or may not be used in practice at our schools.

Gender Affirming Care

All materials provided to staff containing the term "Gender Affirming Care"

Response: The term "Gender Affirming Care" is not part of the training or materials we provide our staff.

Materials provided to students

You requested all materials provided to students relating to these specific terms:

- Gender identity
- Sexual orientation
- Antiracism
- Drag queen
- Gender affirming care

Response: Our district (and all Idaho districts) are required to follow Idaho Content Standards. These standards are available on the Idaho State Department of Education's <u>website</u>.

The terms you listed are not part of Idaho's standards for learning, and our district has not adopted additional standards in these areas. We adopt curriculum based on those standards. Publishers do not create materials unique to each state so adopted materials could contain these terms but these sections or information would not be used in classroom instruction.

Curriculum

Our district adopted curricular materials that are available for your inspection in person. School starts Aug. 21 and 22, so access to these materials will need to be made by appointment, to provide staff time to pull the materials for your in-person review.

Supplemental materials

Our certified staff also use supplemental materials such as newspapers, novels etc. that could contain the terms specified. To fulfill your request, individual teachers would need to search their supplemental materials to determine if any of these terms are present and would be records to provide in response to your request. Again, any materials used are subject to the above-mentioned policies of 2340 and 2340F.

We estimate a search of supplemental materials for the five terms you have identified and for the time period specified would take significant time by our staff. Idaho law allows for two hours free of charge, which have been exhausted for this current request. Law provides for the charging requestors cost of providing the records beyond the two hours. In addition, the cost can be required in advance.

Costs

Given the time it will take to compile and review the records requested beyond what I have provided will require an estimate of the cost to fulfill your request. Idaho law and Emmett Independent School District policy allow the first 100 pages of paper copies and the first two (2) hours of labor to fulfill a request be provided free of charge.

For requests that will take longer than two (2) hours to fulfill, or where records must be reviewed by a staff member or attorney for confidentiality prior to disclosure, the law allows the District to charge to process the request. Based on these requirements, and your request, we will need to prepare an estimate of the cost to be pre-paid to complete your request should the above information provided not be found satisfactory.

Please let us know how you would like to proceed with this matter. We will not move forward with processing this request further until we hear from you about whether the above information satisfies your request, or if you would like to proceed with a cost estimate based on your further information request. Please note: more narrow, specified information will allow us to provide a better estimate.

Mr. Collins:

Hello! By your further requests, I'm afraid we may have a misunderstanding regarding restorative justice. First of all, I'd like to clarify what we mean by restorative justice, as it is used in our district. Once we have a mutually-understood definition, please fill out the attached Public Records request form so we can log the request in our system and provide you what you need.

In Emmett School District, restorative justice practices are currently used at our Black Canyon High School. Black Canyon is an alternative high school. Restorative justice refers to practices that focus on alternatives to traditional punishment. Offenders must accept responsibility for harm and make restitution. For instance, if a student commits an offense, administration may seek an alternative method rather than a traditional suspension, which would require the student to miss school. Restorative justice in Emmett School District does not in any way relate to race or history, nor do we teach such practices, nor does our curriculum contain anything related to such practices or theories.

Restorative justice is simply used as a tool in discipline and interactions, providing alternatives to traditional punitive discipline and encouraging students to develop responsibility and accountability in ways that restores them to fully participate in education. It encourages students to understand the harm and consequences of their behavior, provides an opportunity to redeem themselves, and discourages them from causing further harm.

To further clarify, there are no reading materials provided to students regarding restorative justice at any grade level. *How to be an Antiracist* is not included in our district in any capacity. Staff has received training in restorative justice as it relates to educational practices that fit the definition described above. Again, in confirming that we use restorative justice practices, that term in no way includes anything related to history or race, especially as used in practice by the Emmett School District.

If you continue to have requests beyond my clarification, please complete the Public Records request provided. Please be as specific as possible so I can locate the information you seek.
