



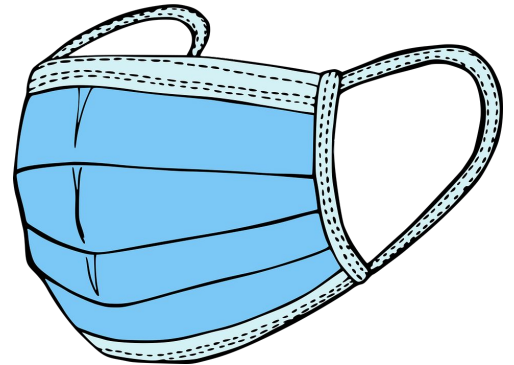

Safe, In Person Learning

- Providing safe, in person learning for our students is our top priority
- In order for us to provide in person learning, safely, we must follow public health guidelines, which currently includes requiring masks to be worn indoors.



2021-22 School Year

- August 18th-First Day of School for students
- All schools will open with 100% in person instruction available for all students
- Current public health guidelines require all students and adults to wear a mask indoors in all K-12 schools
- Masks are not required to be worn outdoors
- There are no physical distancing requirements at this time
- Per Assembly Bill (AB) 104, any student who earned grades in TUHSD during the 20-21 school year, may request a grade be changed to Pass/No Pass
- Per Assembly Bill (AB) 130, The District will provide an Independent Study learning option for student's/families who do not wish to return to full-time in-person learning due to extenuating circumstances.

Assembly Bill 104 Details

- Assembly Bill 104 provides all students who earned a letter grade in any course during the 2020-21 school year the opportunity to replace the letter grade with a Pass/No Pass grade
- The Pass/No Pass in place of a letter grade does not negatively impact a student's GPA
- There are no limits to the number of grades earned during the 2020-21 school year that a student may request be changed to a Pass/No Pass
- Any grade D- or higher may be changed to a Pass
- Any grade of F may be changed to a No Pass
- A grade of incomplete may not be changed to a Pass but can be changed to a No Pass

AB 104 Timeline

- Assembly Bill (AB)104 established a strict timeline for the District to make a grade change application available and for students/parents/guardians to submit the application
- The District made the application available on July 30th
- Per AB 104, students/parents/guardians have 15 days to complete the application process
- The District must make the adjustments to a student's transcript within 10 days of receiving the request

AB 104 Deadlines and Communications

- All students and parents/guardians of students who earned grades from TUHSD during the 2020-21 school year was sent an email with an explanation of AB 104 on **July 7th**
- A second email was sent to all students and parents on **July 30th** with the application for grade change and the timeline for submission
- The application for a grade change can be found on the District website
- All grade change applications are due **midnight on Sunday, August 15, 2021 (per AB 104)**
- **Most UCs and CSUs will accept Pass/No Pass as will some private colleges and universities. However, out of state colleges and universities may not accept the Pass/No Pass.**
- **Students should inquire directly with school to which they wish to apply that are not on the CDE list of those who will accept the Pass/No Pass**

Assembly Bill 130

- Independent Study Requirement
- The District offers an independent study option through Tamiscal High
- We will also be providing an new Independent Study option for students who do not wish to return to live in person instruction for this year-we will have more information available on that option out to families by August 9th.

Graduation Requirements

- AB 104 also requires districts to waive local graduation requirements that are not aligned to the state minimum requirements for students who were in the 11th or 12th grade during the 2020-21 school year
- TUHSD Board amended the graduation requirements in May to adhere to this requirement
- This is done on a case by case basis and does impact a student's UC/CSU eligibility
