

ENDOWMENT

Investment income from the Burroughs endowment is a perpetual source of revenue that supports the school's operating budget. Often, gifts to our endowment are restricted to support tuition aid, a hallmark of the Burroughs program. While tuition aid has been offered for decades, it wasn't until 1947 that Burroughs received its first gifts to endow two separate scholarships.

The Burroughs endowment safeguards the school's long-term financial health. Our focus on expanding the endowment reflects ongoing evaluation of our financial position against market trends (declining birth rate in the U.S.), our bottom line (tuition income currently covers 77% of our operating expenses), and market limitations (our tuition cannot dramatically outpace our local peer schools).

Today, approximately 25% (160 students) receive tuition aid, totaling more than \$4.1 million. Offering robust tuition aid has always been essential to attracting the best students to Burroughs regardless of family income. As a result, our student body is increasingly representative of the larger population, yielding a more inclusive and dynamic community of students and families who collectively make the Burroughs experience more meaningful and welcoming for all.

Today, we have 81 named endowed scholarship funds that collectively provide 30% or more of our annual tuition aid budget, depending on market returns. Of these endowed scholarship funds, 36 are not yet of a market value to support a quarter scholarship and are "pooled." As a result, we ask friends, families, and alumni to consider making gifts or bequests to further endow tuition aid at Burroughs. Gifts of any amount can be directed to an existing scholarship, and gifts of \$100,000 or more can establish a new endowed scholarship fund.

ST. LOUIS AREA TRENDS UNDERSCORE NEED FOR MORE ENDOWED SCHOLARSHIPS

Families with incomes of \$200,000 or less generally qualify for tuition aid. Recent census data indicates that 89% of families in the St. Louis area have annual incomes less than \$200,000. Below is a snapshot of two regional data points from 2022 that underscore the importance of planning for a future in St. Louis in which fewer families will be able to pay full tuition.

Additionally, the number of children living in the 100 largest cities decreased from 14.2 million in 2010 to 13.9 million in 2020. In Missouri, the state's under-18 population dropped by 3.2% between the 2010 and 2020 census. Overall, birth rates plummeted for Americans between 1976 and 2018. With fewer kids, and fewer families able to afford private school tuition, Burroughs must position itself to attract and retain the region's most talented students regardless of family income.

This will be a full scholarship.

CAROLINE GASKIN LAVIGNE '92 SCHOLARSHIP +

Established in 2023 by Mark LaVigne to honor his wife and to celebrate her service to Burroughs between 2001 and 2023 as a faculty member (English) and as the Director of Admission and Tuition Aid. This scholarship will support a student with demonstrated financial need, decrease financial barriers for qualified students, and strengthen the school's endowment, thus ensuring Burroughs' long-term financial health and resiliency. This will be a quarter scholarship.

ELLEN Y. MOCERI SCHOLARSHIP

Established in 2023 by JBS alumni to honor Ellen's service to Burroughs between 1966 and 1993 (History & College Counseling). Ellen is famous for her Honors Russian Studies class — a combination of Russian history, literature, economics, and sociology. She is also credited with bringing Aim High to Burroughs in 1991 in partnership with the late Rick Sandler (English). Ellen served in administrative roles in multiple independent schools for over 49 years. In 2001, she joined Ransom Everglades School in Florida as the head of school. Ellen returned to St. Louis in 2014 and volunteers on multiple boards. This is a pooled scholarship.

SCHNUCK FAMILY SCHOLARSHIP +

Established in 2023 by the Schnuck Family: Craig '66 and Nancy Schnuck, Scott Schnuck '68, Terry '71 and Sally Schnuck, Mark '74 and Stephanie Schnuck, Todd '77 & Julie Schnuck, D.J. and Nancy Schnuck Diemer '83, and Stephanie A. 2024–2025 ENDOWED SCHOLARSHIP LEVELS

Tuition aid is awarded on a sliding scale according to demonstrated need. With tuition of \$36,300, most families with household incomes of \$200,000 or less qualify for some level of tuition aid. Tuition assistance has increased from \$495,000 in 1989 for 110 recipients (19.8% of our students) to \$4.1 million in 2023 for 160 recipients (25% of our students) for the 2023–2024 school year.

Endowed scholarship levels fluctuate each year with tuition increases. Current scholarship levels are listed below, based on a tuition of \$36,300 for the 2024–2025 school year.

ENDOWING THE BURROUGHS CORE

On June 30, 2023, the collective market value of all endowed funds to support the Burroughs core courses was approximately \$6 million, which generated \$270,000 in investment income, or 1% of our total program expenses for the 2023–2024 school year.
