Dear Parent/Guardian:

Attached is a copy of the "Home-Based Instruction in Lieu of Attendance or Enrollment" form. This statement must be filed no later than September 15th if your child is going to participate or continue in home instruction instead of attendance in our school or an approved private school or extension program of an approved private school.

Please be aware that you are to be knowledgeable and subject to the requirements of Chapter 28A.27 RCW and RCW 281.27.010(4). As part of these requirements, in addition to the annual signed declaration of intent, you are also to ensure test scores and annual academic progress assessments and immunizations records are kept relating to instructional and educational activities provided. Such records will be essential should you ever want to transfer your child into a .

public school or approved private school. Please be aware that the granting of credit for home-schooling, upon transfer into a public or private school, is the prerogative of that school. There is no automatic public school acceptance of home school credits upon transfer into a public school.

Finally, you are to ensure that a standardized achievement test approved by the State Board of Education is administered annually, or that an annual assessment of the student's academic progress be written by a certificated person working in the field of education. This test or written annual academic progress assessment is to be a part of the child's Permanent Record.

Declaration of Intent to Provide Home-Based Instruction Year 2022-2023

A parent who intends to cause his/her child or children to receive home-based instruction in lieu of attendance or enrollment in a public school, approved private school, or an extension program of an approved private school must file an annual declaration of intent to do so in the format prescribed below:

I do hereby declare that I am the parent, guardian, or legal custodian of the child(ren) listed below; that said child(ren) is (are) between the ages of eight and eighteen, and as such, are subject to requirements found in Chapter 284.225 RCW; Compulsory Attendance; I intend to cause said chi/d(ren) to receive home-based instruction as specified in RCW 284.225.010(4); and if a certificated person will be supervising the instruction, I have indicated this by checking the appropriate space.
