There were numerous community engagement opportunities during the school year to gather feedback about how to use ESSER III funds. We reached out to multiple groups who have provided feedback on the creation of our district's programs and service for students. This

feedback was used in the development of the ESSER III expenditure plan. Community engagement opportunities targeted the following stakeholder groups: students, parents/guardians, school and district administrators, teachers, support staff, as well as Homeless, Special Needs, and English Learner families. Family and staff surveys were sent out to all parents and staff. Additionally input was gathered during Booster Club (parent) meetings as well as Board of Trustee meetings.

Suggestions from the above mentioned community engagement opportunities include services and opportunities for students and were incorporated into the development of the ESSER III plan. In our survey results as well as in our public board meeting, the members noted the need for a full day nurse to assist with the medical needs and fragile health students so that they can access in person instruction. The parent and staff survey as well as certificate and classified meetings shared the need to upgrade our facilities hvac system in our current cafeteria to allow for future multi-use of the room throughout the day, even in the heat of summer so that students can focus on their learning in a safe environment, and the need for a kindergarten shade structure to provide outdoor seating for meals in a safe cool condition during the warm months. The need of technology devices were noted in survey information from our parents, certificated and classified staff members, as a continuing need to ensure our students' academic success.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
