Academic progress is reported to parents via:

- Important announcements will continue through the School Messenger program
- ClassTag will be the primary means for daily announcements.
- Annual Title I meetings will be held each year in the first quarter.
 - o At this meeting, families will be informed of the school's Title I program and budget, and the right of parents/guardians to be involved in their child's education

Parents can make suggestions and participate in decision making at PHHS via:

- Parents are invited to involve in Membership on the Site Council
 - o This includes participating in development of the Campus Improvement Plan (CIP)
 - o The Title I Parent-School Compact is reviewed at this meeting annually
 - o The Parent Involvement Policy and Procedures for Harmony will be reviewed annually
 - o The Title I budget is reviewed annually
- Individual conversations with counselors

- Conferences virtual or in person
 - o Parent-Teacher Conferences each semester. Offer flexible times or house visits for parents who are not available during weekdays.
 - o Individually schedules conferences.

- Provide information regarding qualifications of a child's teacher, when requested.

- Coaching and/or mentoring opportunities will be available to interested parents, in athletic and/or academic areas on campus.

Parent Responsibilities:


We, as parents, will support our children's learning in the following ways:
