Welcome

The District 11 DAC and its subcommittees continue to work diligently and deliberately as we reach the halfway point of the 2020-21 academic year. In this unique school year we continue to adjust to support SACs and the Board of Education (BOE). We are proud as a DAC that every school in District 11 has a School Accountability Committee (SAC). We reached out to all SACs to ask for parent volunteers for the Equity Audit Focus Groups. Here are a few other highlights on what was accomplished in the month of November.

- The DAC Charter School Subcommittee finished the review of the Inventa Academy Charter School application and provided a recommendation for the BOE. Thank you to Dr. Wendy Chiado, Chris Kilroy, Steve Lambert, Vicky McLaughlin, and LynDel Randash for working on this subcommittee.
- The Training and SAC Support Subcommittee hosted the 2nd SAC Webex Training Session on November 5th, 2020. The training included a discussion of staffing challenges and the new Unified School Improvement Plan tool. Breakout sessions were provided on Trauma Informed Care, the READ Act, and D11 Security Operations. The training was positively received. The 3rd SAC Training Session is scheduled for January 28, 2021.
- The DAC Budget Subcommittee started the process of reviewing the 2020-21 midyear budget modification requests. The subcommittee will continue this process in December and provide a comprehensive recommendation to the BOE.
- The DAC Accreditation Subcommittee continued to press ahead. The committee
 looked at the survey results from the Return to Learn surveys, elementary school enrollment losses, a comparison of Universal Screener results, and distance learning
 approaches at the elementary school.
- The DAC planned on reviewing the recommendation from the DAC Charter School Subcommittee for Inventa Academy. The recommendation was provided to the DAC and the BOE. Inventa pulled their application before the final review so the DAC meeting in November was cancelled. We will have a meeting in December.

Lastly, the DAC would like to thank everyone in the D11 community for voting to pass ballot issue 4A to allow the district to retain money restricted by the TABOR amendment. This is positive for the district and the community.

<u>School Capacity Committee Report for 2020 – 2021</u>

- Deputy Superintendent David Engstrom, briefed the School Capacity Committee Report for 2020 2021 at the October 28, 2020 Board of Education meeting.
- The report updates student capacity for each D-11 school based on a defined capacity model and also provides information on student enrollment and building utilization based on the capacity model.

- The School Building Detail Report, a sub-component of the committee report, provides individual school profiles with five years of trend data on student demographics, school utilization, and academic results. New D11 Education Insights Department (formerly Educational Data and Support Services (EDSS) Department)

- Within the newly redesigned Education Insights Department, headed by Dr David Khaliqi, are 3 offices; Enrollment, Assessment, and System Improvement. This re-naming of EDSS to Education Insights reflects a deeper strategic approach to merging diverse data sources into a coherent whole that examines inputs, processes, and outputs in a more sophisticated, whole-student fashion moving beyond the traditional one-dimensional, single measure approach.
- The Education Insights Department will continue to serve the D11 community by providing the
 traditional data, assessment, and enrollment services that it always has. The Office of System
 Improvement has been added to provide guidance, support, and accountability toward continuous
 improvement for schools and central administration using the Strategic Alignment Planning process.

Upcoming deadlines of interest to SACs

- Any budget/funding recommendations for 21-22 must be submitted to DAC by Feb 1, 2021
- READ Act: DIBELS Next Middle of Year (MOY) testing for K-3 (Nov30th Dec 18th).
- Galileo K-12: Universal Screener second quarter ELA and Math tests (grades 2-5) will be Nov 30th Dec 18th. Testing for grades 6-8 will be Jan 11 29th 2021.
- ACCESS, the state test for English Language Learner (ELL) students (all eligible kindergarten 12th grade students), will be given Jan 11th Mar 12th, 2021.

SAC NEWS/NOTES (CONTINUED)

SAC Agenda Planning – December/January (Theme: Catch-up and Safe Learning Environment)

Every month we intend to provide a reasonable flow of SAC agenda topics that meet the broad responsibilities of School District 11 SACs. This is just a reference tool and individual SACs should tailor agendas appropriate to their school needs and emphasis. The following are some of the agenda topics that are recommended for the December and/or January SAC meetings:

- Review/discuss topics from the D11 SAC Handbook, Agenda Planning Guide for previous months which have not yet been addressed.
- Review/discuss safe learning environment for the school (safety, discipline, attendance, response
 to COVID-19 events, etc.). Your principal has current discipline and attendance statistics, broken
 down by poverty and ethnicity subcategories, for the entire school in summary format which
 should be shared periodically with the SAC to discuss trends. What is the chronic absenteeism rate
 for your school and how is it being mitigated given the challenges of COVID-19? [Note: For MS and
 HS SACs, this data should be available from the D11 Early Warning System data package.]
- Review/discuss the school's focus on parent strategies for individual student support as well as
 teacher/parent communication. Is school administrative staff working to update parent/guardian
 contact information for errors noted on communications rejection reports? Are teachers using the
 communications capabilities in Schoology and other platforms to communicate effectively with parents and students? Note: Check out https://www.d11.org/techtips for more ideas and resources.
- Review/discuss with the principal the school's implementation of the educator evaluation system and alignment with instructional goals. Note: CDE just approved significant changes in the approach to teacher evaluations for school year 20-21.
- Review/discuss school budget alignment with USIP goals and identify school funding shortfalls, e.g.;
 - Instructional resources to meet transition to new state standards or multiple learning environments
 - ♦ Technology resources needed for student teaching/learning/testing, including as appropriate for quality hybrid learning and remote learning environments
 - Note: Budget/funding recommendations must be submitted to DAC by Feb 1, 2021 to be considered for the school year 21-22 budget.
- Review results of available performance monitoring data, e.g. Galileo K-12, 2nd round Universal Screener results, and compare to USIP targets. Is your school meeting or exceeding its student growth targets? What strategies is the school using to assist students who are struggling the most, and are they working?
