WHEREAS the Board of Education of Evanston Dists 65/202 Jnt Agr, County of Cook, State of Illinois, caused to be prepared in tentative form a budget, and the Secretary of this Board has made the same conveniently available to public inspection for at least thirty days prior to final action thereon;
