### CLASS TITLE: INTERSESSION DAY CAMP CUSTODIAN

### **BASIC FUNCTION:**

Under the direction of the District Administrator of Expanded Learning Opportunities and the Director of Facilities, Maintenance & Operations, Intersession Day Camp Custodians are responsible for properly maintaining the site grounds and facilities of the district in a safe and efficient manner by providing proper maintenance to ensure the interior and exterior environment is safe, secure, and aesthetically attractive. In addition, these positions support Custodial Operations by performing cleaning duties, as needed and directed, to provide students, employees, contractors, and community with a safe, attractive, comfortable, clean, and efficient place in which to learn, play and develop in a day camp style setting in partnership with Elevo Coaches to provide a full 9 hour day enrichment program for students.

### REPRESENTATIVE DUTIES:

#### **ESSENTIAL DUTIES:**

Performs and all custodian cleaning duties as assigned.

Maintains buildings (restrooms, floors, windows, etc.)

Moves and arranges furniture and equipment.

Report safety, sanitary and fire hazards to appropriate personnel; report need for maintenance and repairs to appropriate authority.

Prepares school for opening/closing.

### OTHER DUTIES:

Performs other related duties as assigned which are reasonably related to the above.

### **KNOWLEDGE AND ABILITIES:**

#### KNOWLEDGE OF:

Preferred methods of cleaning and preserving floors, walls and fixtures.

The use of cleaning materials, disinfectants, and equipment used in custodial work; of tools (and ability to use them) in minor maintenance work.

Ability to quickly learn schedules and procedures.

Ability to perform physical labor including lifting in excess of 50 pounds.

Understand and carry out oral and written instructions.

Establish and maintain cooperative relationships with students, parents, faculty, staff & contractors.

# **ABILITY TO:**

Communicate effectively both orally and in writing.

Establish and maintain cooperative and effective working relationships with others.

Operate assigned cleaning equipment.

Analyze situations accurately and adopt an effective course of action.

Meet schedules and timelines.

# **Intersession Day Camp Custodian - Continued**

Work independently with little direction. Plan and organize work.

### **EDUCATION AND EXPERIENCE:**

One year of experience in comparable field.

Any combination equivalent to: sufficient training and experience to demonstrate the knowledge and abilities listed above.
