80 incidents were reported, 33 were confirmed to be HIB

Reported by: 1 anonymous, 22 by parent, 15 by staff, 43 by students

Of the 33 confirmed: 3 on the bus, 11 in classroom, 8 online, 8 within the school building, lunch/recess, 1 after school activity


