New Education Visa

Changing a Tourist Visa (TR Visa) to a Non-Immigrant Education Visa (ED Visa)

REQUIRED DOCUMENTS

- · Original Passport (at least 6-month validity and 2 blank visa pages)
- Father or Mother bio page of the passport and a visa page
- Six Passport-Sized Photographs (white background taken within the past 6 months)
- Student's Birth Certificate (legalised signed copy, translated into English)

COSTS (THB)

New Education Visa - 15,000 Education Visa (Transfer or Renewal) and Guardian Visa -- 10,000 Document Pack Only - 1,000

REQUIRED DOCUMENTS

- · Original Passport
- Two Passport-Sized Photographs (white background taken within the past 6 months)

RENTAL RESIDENCE EVIDENCE

- Residence Receipt ('Notification From the Immigration Office')
- · Rental Contract
- · Current house registration
- Copy of the title deed on both pages (signed)
- · Copy of the Sale Agreement (signed)
- Copy of the Landlord's ID Card for Thais (still valid)
- Copy of the Landlord's passport (still valid) with the Thai visa page for foreigner
- Copy of the Landlord's house registration for Thais
- DBD Letter if the owner bought the house under the company name

OWN RESIDENCE EVIDENCE

- Residence Receipt ('Notification From the Immigration Office')
- Current house registration
- Copy of the title deed both pages (signed)
- · Copy of the Sale Agreement (signed)
- Copy of the Landlord's passport (still valid) with the Thai visa page for foreigner
- DBD Letter if the owner bought the house under the company name

NOTES:

- BOARDERS: Students resident in our boarding houses do not require evidence of residence.
- PHOTO EVIDENCE: Photos required for own and rental evidence are of the front of the house (must show house number) and inside the house showing each room.

REQUIRED DOCUMENTS

- The initial application requires a 30-day bank statement showing a minimum balance of 500,000THB for each day prior to the application date.
- Subsequent renewals require a 90-day bank statement showing a minimum balance of 500,000THB for each day prior to the application date.
- Original Passport
- Two Passport-Sized Photographs (white background taken within the past 6 months)
- Previous Three Months Bank statements
- Original Bank Book (showing credit of at least 500,000 THB in past three months)
- Copy of Bank Book (every page)
- Student's Birth Certificate (legalised signed copy)

- Residence Receipt ('Notification From the Immigration Office')
- · Rental Contract
- · Current house registration
- Copy of the title deed both pages (signed)
- Copy of the Sale Agreement (signed)
