## Parents/Guardians:

I am writing to inform you of the state and standardized testing schedule for Park Ridge students during the 2024-2025 school year. There is one new test this year: the NAEP (National Assessment of Educational Progress) will be administered to our fourth grade students in West Ridge.

Sometimes called "The Nation's Report Card," the NAEP is a measurement of student achievement in ELA, mathematics, and many other subjects. West Ridge students will only take the reading and mathematics portions of the test. The Federal government chooses districts, schools, and grades, across the nation, to participate based on a sampling formula. This year, West Ridge grade four was one of the groups of students chosen. Since Park Ridge School District receives Federal funding, the district's participation is mandatory. The results of this assessment often determine educational policy at the federal level, and student progress as measured by the test is often used as a measure of student achievement nation-wide.

The New Jersey Graduation Proficiency Assessment (NJGPA) will be administered this spring to current Juniors (Class of 2026). Current law requires that the NJGPA be the primary graduation requirement for the Class of 2026. Students must achieve a designation, based on a cut-score set by the legislature, of 'Graduation-ready' to qualify for graduation. For students who require them, there are other pathways to graduation as long as the student has attempted the NJGPA. Full information about graduation requirements can be found online on our Curriculum Department's website, or you may contact your child's school.

The dates of the Spring 2025 exams in the chart below are the Testing Windows set by the State Department of Education or vendor. As these exams draw nearer, your building principals will reach out with more information, including exact testing dates.
