2024-2025 School Year Financial Aid Application Fee:

Documents:

The following supporting documents must be mailed, faxed or uploaded to FACTS within a week of submitting an online application.

- Household members' most recent completed federal tax forms (personal and business owned).
- W-2's from each job held by household members.
- Two most recent pay stubs from each job held by household members.
- Forms 1099 or other documents that establish the amount of miscellaneous monthly or yearly income you currently receive (i.e. welfare, food stamps, unemployment, workers compensation, etc.)
- All corporate, partnership, and trust forms if a household member owns 20% or more interest in a corporation, partnership or trust. Send copies only; do not send originals.
- Special circumstances? If so, submit a typed or written letter with your documents.
- Note for separated or divorced parents and single-parent households: Although FACTS does not require income documentation from non-custodial parent, FACTS does require the custodial parent to send documentation regarding alimony and child support received (section 5) and alimony and child support paid (section 16). If the biological parents share joint custody, then income documentation from both biological parents is required.

Application Priority Deadline:

December 31, 2023

All materials must be submitted to FACTS. Applicants may be required to include the confirmation printout from your final online session. Please write your FACTS ID number on all documents.

Award Notifications Mailed:

Award notices will be sent beginning the second week of February for applications received by FACTS by December 31, 2023 who have completed both the Admission Application and Financial Aid Application processes or if they are a currently enrolled student for the 2023-2024 academic year. Late financial aid applicants' award notices will be considered based on availability of funds.
